## MATTERS ARISING - A GUIDE TO THE GROUPS

In this issue of Along the Towpath there are reports assembled from information provided by the C & O Canal National Historical Park and its Advisory Commission, and the C & O Canal Association's general membership, Board of Directors and level walkers. These reports have appeared in newsletters from time to time (some in nearly every issue), but this time, in a rare coincidence, they appear together in one issue. Given this happenstance and the observation that no space in this newsletter has been devoted recently to an explanation of the relationships among these groups, your editor offers the following brief, graphical and inexhaustive orientation.

In the figure below, the underlined words refer to documents which are summarized or excerpted from in Along the Towpath.

Appointment of Members and Terms of Office

The persons working for the C & O Canal National Historical Park are employees of the National Park Service.

The members of the Advisory Commission are appointed by the Dept. of the Interior. There are 19 members on the Commission: two from each of the states of Md., Va. and West Va. and the Maryland counties of Allegany, Frederick, Montgomery and Washington, and the District of Columbia, and 3 at-large. The terms of the present members expire in January 1982.

The members of the Board of Directors of the C & O Canal Association are elected by the membership once a year. There are 15 Board members, serving three-year terms, with five elected each year.

The officers of the Association are elected each year for one-year terms.

As it has turned out, many of the members of the Advisory Commission are Association members.

#### CANAL HERITAGE WALK

Save October 24, 1981, for a day of pleasant recreation and examination of part of the historical and environmental heritage of the C&O Canal. The walk will cover the 7-mile section from Pennyfield lock (mile 19.6) to Sycamore Landing (mile 27.2), and may include tours of the Dierrsen waterfowl sanctuary and the Seneca sandstone quarries among other events. #### MORE ON HIKANATION

After 13½ months and 4,290 miles of hiking through mountains, desert, snow, rain, and along roadways, footpaths and the Harpers Ferry-Georgetown section of the C&O Canal towpath, the Hikanation group ended its cross-country hike on May 27, 1981 at Cape Henlopen. Thirty-six of those who started out in San Francisco, Calif. in April 1980 were there at the finish. C&O Canal Association member Susan (Butch) Henley was among them. Butch writes about the last days of the hike:

The Appalachian Trail in (Shenandoah National) park and Northern Virginia was for the most part in excellent shape. Many of our hikers spent a nice evening with Potomac Appalachian Trail Club folks at the Blackburn Trail Center and...stayed around the next day to help improve the access trail.

The hikers regrouped in Harpers Ferry after being well scattered out on the Appalachian Trail in Virginia. We well-joined at this point by many former members who had hike with us at various places across the country and came to share the Washington arrival with us.

The send-off from Harpers Ferry was very nice. (We heard) a few nice, short but inspiring speeches at the Mather Training Center (a NPS facility). We managed to sneak nearly 100 hikers across the railroad bridge. It was a pleasant walk down the towpath in spite of a little rain and a little confusion in interpreting the day hikers' schedule vs. the backpackers' schedule.

The C&O Canal Association, sparked by Joan Paull, welcomed the hikanation to Swains Lock with banners, food and a real fanfare complete with flag waving, from a one-woman Kazoo band.



NOTES OF THE ASSOCIATION BOARD MEETING OF MAY 31, 1981

Douglas Memorabilia

The Washington County Historical Society in Hagerstown will probably be willing to store the Douglas memorabilia which the Association will receive from the William O Douglas estate. The next Board meeting will be held at the Society, and a group of Association members will meet at the Society one hour before the meeting to examine the Society's facilities, and to determine if the Society's proposed arrangements for maintaining the Douglas materials would be acceptable.

The President Met with the Superintendent

President Chandler and Superintendent Stanton met on May 26, 1981. In their discussions Stanton made it clear that he wanted to communicate not only with the Association, but also with other organizations with interest in the canal park. He said, furthermore, that the Association should itself pay more attention to these other organizations of interested citizens. Stanton also said that he thinks the Park Superintendent should be an exofficio member of the Association. Chandler mentioned the Association's concerns with historical preservation, environmental protection and safety.

The Board decided to extend to Dick Stanton "all courtesies" of Association membership except voting rights.

The Newsletter

Board members made suggestions for adding a Park Superintendent's column, an activity column and a history column. These matters will be discussed at the August Board meeting. Members interested in this issue should plan to attend.

Association Meeting Schedules

Board members and officers proposed Board meeting frequencies of four to six times per year at various locations up and down the canal. A general membership meeting in December 1981 near Shepherdstown was recommended.



The President's Column

#### REDEDICATION

Some have said that the C and O Canal Association no longer has a mission. The struggle to save the Canal area from highway development has been settled. The adoption of the area as a National Historical Park has been accomplished. The preservation of the area has been placed in the competent hands of the National Park Service. And the C and O Canal Commission has been set up to provide citizen participation in the month-to-month tasks of managing and maintaining the Park.

At present there seems to be no reason for a dramatic call to action, such as Justice Douglas' 1954 challenge to the editor of the Washington Post. Nor is there a need for strong appeals to Congress for support of canal-related legislation. Today's challenges are not so easily dramatized or so sharply focused. The basic values that made the Canal area so worth the struggle for protection remain unchanged. Also, many interests that are incompatible with the historical park concept continue to seek conces-

sions or advantages in the Potomac valley region. The challenge is to keep the concepts of historical preservation and environmental protection in the forefront as the siren songs of new appeals for special use or river development are heard. The Canal may no longer face obliteration, but its value as a sanctuary for the foot-traveler or stroller could be subtly eroded if more intensive patterns of use are permitted. Perhaps it is not too early for a rededication to the historical park concept. As we enjoy walking along the towpath, singly or in groups, we can remind ourselves that the Park was created "to preserve and interpret the historic and scenic features of the Chesapeake and Ohio Canal."



NOTES FROM THE C&O CANAL NHP ADVISORY COMMISSION MEETING OF APRIL 18, 1981

## The Seemingly Interminable Process of Planning. . .

The National Park Service agrees with the Commission that planning in the Park takes too long. Superintendent Stanton told the Commission that he thinks it is possible that the Development Concept Plans for Cumberland/North Branch, Great Falls, Brunswick and Williamsport could all be approved by the end of 1981. In order to do this, the NPS proposes to establish a planning team of about seven members for each area. The members of the team would include a (professional)

planner as the team "anchor," Park staff members, two Commission members, one or two local adult residents and one local adolescent. Furthermore, the entire plan will be explained on one side of a single piece of paper and mapped on the other. The Commission supported the Park Service's proposal. Whether this new planning system will speed-up planning remains to be seen; perhaps one could argue the merits of a slow, even an agonizingly slow, procedure. Nevertheless, to those closely involved in Park planning, its snail's pace has been enervating. As John Millar, chairman of the study team for the Cumberland/North Branch Development Concept Plan, concluded his status report:

We have been working on the Cumberland/North Branch Development Concept Plan for a couple of years. I personally have spent hundreds of ...hours on it with significant help from...other interested parties. (The) NPS (and)...the Advisory Commission (have) spent a lot of time on it. By now everyone should have had sufficient opportunity to participate in the...Plan. My final question is, "What can we do to complete the Development Concept Plan and get on to something else?"

#### . . . And the Status of the Plans

Cumberland/North Branch: Both the study team and public citizens support Alternative 3B, which calls for rewatering nine miles of the canal, from Spring Gap to the waste weir at mile 183.5 (Candoc), one mile below the terminus. Alternative 3B also includes restoring lift locks 72-75, lockhouse 72, Evitts Creek aqueduct and the steam pumping station; adding parking for

30 cars, a john and a food/boat/bike/horse concession at Spring Gap; adding a Park office, john, food concession and parking lot for 200 cars at North Branch; using the Western Maryland railroad station for dispensing visitor information, and adding parking for 75 cars, Landscaping, a john, a water fountain and a Wiley Ford towpath pedestrian overpass at the terminus.

The Plan, however optimistic the NPS is of approval by the end of 1981, still must negotiate an NPS draft decision document, a review of this document by the Commission, a 30-day waiting period, and the Regional NPS director's scrutiny. The final public hearing was held in June, and written comments will be accepted until July 17, 1981.

Williamsport: "Base data" has been collected, and the planning team

members should have been selected by June 1981.

Great Falls: The decision document has been released for the 30-day public comment period. If there are no objections from the public or the Commission at the end of this time, the plan will be finished.

Brunswick: Paul Letterer is to be the planning team "anchor" for this plan (and for the Williamsport plan). Letterer has planned for the Alexandria waterfront redevelopment project.

The National Park Service now owns the six miles of abandoned rightof-way in West Virginia, finally bringing an end to the acrimonious controversy over the disposition of these lands. The NPS met with Morgan
County Commissioners and citizens to determine what should be done with the
new acquisition; as a result the Park Service will consider allowing adjacent property owners to use the Park Service lands by special use permit
or other legal means. The NPS has already erected barricades to prohibit
access to the Potomac river bridges along the abandoned right-of-way.

Hancock Rewatering

The project to rewater a mile-and-a-half of the canal at Hancock has been approved by the National Park Service. Hancock requested the rewatering for enhancement of both recreation and fire protection.

#### Other Items

A new terminus monument was dedicated at mile 184.5.

The Commission declined to change its 1980 opinion that bluestone (evidently including crushed limestone) should not be used on the towpath.

Potomac Edison company has agreed to donate the railroad lift bridge over the canal at Williamsport to the NPS. Potomac Edison became the owner when the Western Maryland railroad abandoned its Williamsport branch line, which included the bridge.

The state of Maryland wants to exchange lands with the NPS to widen state route 51.

The Georgetown wall repair work is ahead of schedule and should be completed by the end of August 1981, with the canal rewatered there shortly afterward.

The NPS would like to acquire 24 tracts of Land for the Park, but currently has no money to do so.

The former owner of McMahon's mill has moved most of his machinery out of the mill. The mill will probably be preserved, stabilized and secured.

When completed, the Sycamore Island bridge repair will have cost \$45,000.



#### RECORD OF DECISION - GREAT FALLS DEVELOPMENT CONCEPT PLAN

The document called the Record of Decision encapsulates the final plan for the area. The Record of Decision, therefore, should be a useful reference for those interested in anticipating the changes likey to take place in the area. The Record of Decision is a public document, and interested readers may apply to the National Park Service, C&O Canal National Historical Park, PO Box 4, Sharpsburg, MD 21782, for a copy. A brief summary appears below.

Interpretation: A series of wayside exhibits are being installed at four locations along the towpath: the stop lock, the River overlook between the stop lock and lock 17, the Washington aqueduct and the Gold Mine Tract. These wayside exhibits will feature a brochure for a self-guiding walk. There will be a research library on the second floor of the Great Falls tavern. Lock 20 will be used to demonstrate locking through.

Access and Circulation: Overflow parking along roadsides will be discouraged by a combination of design and enforcement, and entry to the parking area will be controlled. The 40-car parking area nearest to the Tavern will be removed, and the area replanted. The parking area across from the Old Anglers Inn will be paved and striped. The small pull-out at the intersection of Falls Road and MacArthur Blvd. will be improved slightly. The bridge to Olmstead island, allowing view of the falls from the Maryland side of the River, will be replaced. There will be a walk-your-bike rule for bicyclists in congested areas of the towpath.

Other changes, such as towpath modifications in Widewater and use of various buildings, have been addressed in recent issues of Along the Towpath.

Following are observations from level walker reports submitted recently:

#### Sect. 3 - Lock 5 to Cabin John Creek - Phil Stone - May 1981

The towpath continues to be in first class condition throughout my section. The 3 locks (5,6 and 7) and the 2 lockhouses (6 and 7) are in good shape, as is the comfort station at Brookmont. The bridges over the canal and feeder at Brookmont and over the canal at Cabin John are also O.K. I found no evidence of pollution in the canal or cabin John Creek. The litter problem is minimal in the Brookmont-Cabin John stretch of the canal and towpath.

- Sect. 6 Cropley to Great Falls Helen Johnston Spring 1981

  Helen sent a comprehensive and interesting report summarizing her observations for the year. A condensation would not do it justice. However, we do compliment Helen for her dedication and contribution.
- Sect. 8 Swain's Lock to Pennyfield Lock Al Stanley April 1981
  Al reports that general conditions are excellent on this Section, including the HBO at Swains. He has a concern regarding the firing of guns in this area.
  - Sect. 13 Edwards Ferry to Ft. Harrison Island Charles Bookman June 1981 Charles made his first level walk visit to this section and was impressed with its beauty and 19th century nostalgia. He is concerned about the deteriation at Broad Run Trunk.
- Sect. 18 Nolands Ferry to Point of Rocks Kay Seward Spring 1981

  Kay made her initial level walker walk in this area and is delighted with the history and beauty here.
- Sect. 20 Catoctin Aqueduct to Brunswick Lock 30 Helen Glazer April 1981 Helen reported the towpath was in good shape.

- Sect. 28 Shepherdstown to Lock 39 John Frye March 1981

  I have been over this area many times over the past year, the latest, Sunday, March 15, 1981. This level has wintered well and the towpath is clear and in near perfect shape. Certainly this is the type of surface that should be considered for the entire towpath. It has been down at least 15 years, withstood several floods, and today is as good as when applied.
- Sect. 32 Marsh Run Culvert to Dam 4 Edith & Marvin Wilkerson March 1981
  The towpath was in generally good condition. Some work is apparently planned on the railroad-tie retaining wall, above the culvert, which has been damaged by erosion.
- Sect. 33 Dam 4 to Charles Mill Joseph Rowe March 1981
  Walked from McMahon's Mill (Old Charles Mill) to Dam No. 4. The usual single file path leaving the mill is strewn with debris. Mile marker 88 is missing and has been for the last three walks. No. 87 was standing precariously and should be planted. Inlet lock above Dam 4 is in good condition.
- Sect. 35 & 36 Formans Ferry to Falling Waters Howard Thornhill Spring 198 "Thornie" sent us a report when "biking" the 185 miles. He reports that this section is in good shape.
- Sect. 42 Lock 47 to McCoys Ferry A. K. McGraw April 1981

  This section of the towpath is in fine shape no damage noted.
- Sect. 48 Hancock to Roundtop Hill Walter Keefer May 1981

  Walter reports his section is in excellent condition and he sent us this item regarding Roundtop: "Among the oldest and most important industries of Washington County was for many years the Roundtop Cement Works at Hancock, Maryland. The Works were first established in 1837 by a man named Shafer who supplied "Shafer's Cement" for the construction of the canal. In 1863 Shafer sold the property to Robert Bridges and Charles W. Henderson who operated it successfully for forty years. There is a great deposit of rather extensive strata of the cement rock in the hill west of Hancock and the hill has been honeycombed with tunnels from which the rock has been taken."
- Sect. 52 Sideling Hill Aqueduct to Little Orleans Dale Jackson April 1981
  Dale reports that this level is in excellent condition, and noted also that
  the Little Orleans campground was closed.
- Sect. 54 & 55 Lock 59 to Green Ridge Station Robert Woodall May 1981 Locks 59 and 60 are in stable condition. Towpath for entire distance is in good condition. Much improved from last visit. Park Service is to be commended for improving the towpath.
- Sect. 67 Mexico Farms to Evitte Creek Leo Rowan April 1981

  Canal still silted in at mile 178 where brackish run off from area near PPG Company glass dump flows into canal. Canal is well watered up to old Mexico Farms road, prism needs a lot of work from this point on. Culvert 179.10 is in good condition with a steady flow of water. I cleared some stones and leaves from discharge end of culvert. There has been no new work done in the area of culvert-waste weir 179.31. The prism is still being drained at each end by culverts into the Potomac.


