This revision adds in the missing canal boat departures from Cumberland.

Beverly Brooks was born in May, 1827, in Virginia.

The 1850 census reported Beverly Brooks, age 20, a laborer, living in Loudoun County, Virginia. He was living with Nancy Brooks, age 40, Frances Brooks, age 25, Columbus Brooks, age 14, and Mary Washington, age 6. Relationships not reported.

The 1860 census listed Beverly Brooks, age 33, a laborer living in Oldtown, Md.² Living with him were: Martha, age 33, wife; John, age 13, son; and Jane, age 3/12, daughter.

The Civil War began on April 12, 1861.

Beverly Brooks, age 34, joined Company B, 2nd Regiment, Maryland Infantry, Potomac Home Brigade as a private on Aug.12, 1861 in Oldtown, Md. for 3 years. He served many months as a nurse at the Union Hospital at New Creek, W. Va. During July – Aug. 1864 he was in a convalescent camp, Cumberland, Md. He mustered-out on Sept. 28, 1864, at Cumberland, Md., age 37, as a private.

The List of Letter remaining in the Cumberland Post Office on Dec. 31, 1863, included Mrs. Beverly Brooks.³

The Civil War ended on April 9, 1865.

In 1870, canal boats were typically bought for \$1,600 to \$2,000 and we suspect Beverly Brooks bought the canal boat *John* Hammond for cash that year, a deed not being found. The canal boat *John Hammond* arrived at Alexandria, Va., on 5/2, 6/2 and 7/6/1870, bringing coal for the Maryland Coal Co.⁴ We cannot confirm the captain's name. although Capt. Brooks seems likely.

The 1870 census listed Beverly Brooks, age 42, a boatman, with real estate valued at \$200, living in Cumberland, Md.⁵ Living with him were: Martha, age 42, wife; Annie, age 10, daughter; and Chauncey, age 4, son.

We can confirm that the canal boat *John Hammond*, departed Cumberland, Md., on 4/7, 4/26, 5/5, 5/16, 5/25, 6/5, 6/16, 6/27, 7/7, 7/20, 8/7, 8/23, 9/1, 9/12, 9/26, 10/8, 10/28 and 11/18/1871 bound for Georgetown bringing Maryland or Midlothian Company coal.⁶ Eighteen trips, usually taking only eleven days round trip, which would have been running day and night. Four trips took about 20 days round trip, suggesting lay-overs at night.

On Feb. 28, 1872, Beverly Brooks submitted Veteran Pension Application 181.812, with certificate 126.343, as an invalid from his Civil War service. The disposition of his application has not been found. As an invalid, how was he able to captain a canal boat, by hiring helpers?

We can confirm that the canal boat *John Hammond*, departed Cumberland, Md., on 6/1, 6/26, 7/11, 7/16, 7/23, 8/6, 8/20, 9/2, 9/18,10/3, 10/24 and 11/9/1872 bound for Georgetown brining New Central or Maryland Company coal. Twelve trips, usually taking fourteen days round trip, suggesting regular lay-overs at night. Definitely a slower pace than in 1871. Maybe his Civil War infirmities were slowing him down; he had been in a convalescent camp for two months.

On 4/1/1873 Beverly Brooks, of Cumberland, Md., registered canal boat *John Hammond*, Class A, 92' in length, 14' in breadth, 14" in draught empty and 54" in draught loaded. We can confirm that the canal boat *John Hammond*, departed Cumberland, Md., on 4/1, 5/8, 5/19, 7/8, 7/21, 8/7, 9/10, 9/23, 11/12 and 11/28/1873 always bound for Georgetown, freighting New Central Coal Company coal, except the one trip on 5/8/1873 which was Maryland Coal Company coal. The canal suffered freshets on 7/27, 8/1 and 8/16/1873, each of which delayed the *John Hammond* and many other boats.

We can confirm that the canal boat *John Hammond*, departed Cumberland, Md., on 7/17, 7/28, 8/13 10/27 and 11/18/1874 bound for Georgetown, except for the last trip which was bound for Alexandria, Va.¹⁰ There was one spring freshet in 1874, however, the canal was repaired and remained in working order throughout the boating season.

We can confirm that the canal boat *John Hammond*, departed Cumberland, Md., on 4/22, 11/11 and 12/2/1875 bound for Georgetown freighting New Central Coal Company coal on the first two trips and Consolidation Coal Company coal on the last. ¹¹ Surely there is data missing.

We can confirm that the canal boat *John Hammond*, with Capt. Brooks departed Cumberland, Md., on 4/4, 5/5, 5/15, 5/31, 6/15, 6/30, 7/13, 7/25, 8/17, 9/2, 9/28, 10/24 and 12/4/1876 always bound for Georgetown, freighting New Central Coal Company coal. ¹² In 1876 Beverly Brooks, a boatman, was living on Harrison street, Cumberland. ¹³

We can confirm that the canal boat *John Hammond*, with Capt. Brooks departed Cumberland, Md. on 4/12, 4/24, 5/16, 5/29, 6/9, 8/27, 9/5, 9/26, 10/8, 10/23, 11/9 and 11/26/1877 always bound for Georgetown, freighting New Central Coal Company coal. ¹⁴

Notice the gap starting after June 9. In mid-June, several boatmen talked about a strike to raise their pay from \$0.75 per ton to \$1.00 per ton to Georgetown. An actual strike began on or about June 25, 1877 with boats rendezvousing at "Rogue Harbor," about 22 miles above Georgetown. President Gorman visited the boats, advised with them, they concluded to go to work, breaking up the jam of boats. The boats moved up to Point of Rocks and stopped, tying up four abreast so

that other boats could not pass either up or down. The boats came up as far as Sir John's Run, where many tied up and the crews went home for the harvest.

The Sheriff of Washington county and Superintendent Stanhope visited the boatmen at Sir John's Run on Sunday, July 1, and requested them to make way for any boats that desired to pass. That was done, yet 90 boats remained lying there.

Some few boats did pass when they showed a waybill stating their freight was \$1.00 per ton; although other boats with similar waybills from other coal companies were denied transit. On July 26 incendiaries tried to burn the canal boat *A. C. Green*, tied up at Sir John's Run; the attempt failed. However, *Star No.3* was successfully torched on or about July 29th. Things were getting out of hand. The Governor sent in troops starting on August 8. The troops were to disperse between Hancock and Sir John's Run. The strikers demanded their trippage fees be reduced by \$10 per trip. On Aug. 11, Mayor Mayberry, of Hancock, proceeded to the head of the blockade and placed under arrest nine men, ostensibly on the charge of arson in burning the steamer *Star No. 3*, but the boatmen say with a view to remove what they term the "ringleaders." The parties are stated to be John Cahill, Lafayette Eichelberger, N. P. Long, Simon Weston, Robert Reid, George Little, Harvey Davis, Beverly Brooks and Joseph Birch. They were taken to Hagerstown in charge of the sheriff and posse, accompanied by military. ¹⁵

That action effectively opened the blockade and within forty-eight hours everything appeared quiet. The strike had an effect on Beverly Brooks' financial situation. On Aug. 13th 1877, in consideration of \$1,000, Mr. Brooks mortgaged the canal boat *John Hammond*, four mules, their harness, the boat rig, cook stove and furniture. The mortgage was eventually released; the date is uncertain because on 11/27/1896 Frederick Mertens recorded his releases of many, many mortgages, specifying the mortgage but not the date released thereof.

Beverly Brooks must have died after the 1877 boating season, his obituary remains to be found. R. Chew Jones was appointed Administrator for the estate of Beverly Brooks, deceased, and sold Mr. Brooks' personal property on March 27th 1878 for \$700.50 to Daniel Moriarty. We can confirm that the canal boat *John Hammond*, with Capt. Moriarty departed Cumberland, Md. on 4/23, 5/3, 5/20, 6/5, 6/26, 7/9, 7/20, 8/2, 8/23, 9/7 and 9/17/1878. For the balance of 1878, Capt. Russell had the canal boat; which would suggest that Capt. Moriarty did not keep up the trippage payments, the boat was repossessed and sold.

At the request of Frederick Mertens this Mortgage was recorded Aug 16th 1877, at 1:25 P.M.

This Mortgage made on this 13th day of August in the year eighteen hundred and seventy-seven by me Beverly Brooks of Allegany County in the State of Maryland. Witnesseth, that for and in consideration of the sum of one thousand dollars now due from me the said Beverly Brooks to Frederick Mertens of Allegany County, and State of Maryland and in order to secure the payment thereof to the said Frederick Mertens, I the said Beverly Brooks, do hereby bargain and sell to the said Frederick Mertens, the following property: one Canal Boat named "John Hammond" and four mules, to wit: one sorrel horse mule, one bay horse mule, two black mules, one of them a horse and the other a mare mule and the harness that are now used with said mules, and also the boat rig now on the Canal Boat "John Hammond" including cooking stove and furniture on said Boat. Provided that if I the said Beverly Brooks shall pay to the said Frederick Mertens or his assigns the said sum of one thousand dollars with the interest thereon from the date hereof on or before the first day of December in the year eighteen hundred and seventy-seven, then this mortgage shall be void. And I, the said Beverly Brooks do hereby covenant and agree, that if, in default of the payment of the said sum of money, he the said Frederick Mertens or his assigns may, and is hereby authorized to seize said Boat and mules, or any of them, and said harness, boat rig and boat furniture, and sell the same to the highest bidder for cash, whenever the same may be so seized, and taken, after first giving notice by hand bills for at least ten days of such sale, and then pay himself the amount that may be still due to him, and all expenses attending the sale and seizure, and if there be any overplus, to pay the same to me, the said Beverly Brooks, or my assigns.

Witnesseth: that the said R. Chew Jones was by the Orphans Court for Allegany County appointed Administrator of the goods and chattels of Beverly Brooks, deceased. And that the said Orphans Court on the 15th day of March A.D. 1878, passed an order directing the said Administrator to sell the goods and chattels and personal property hereinafter specified, and the said Administrator on the 27th day of March A.D. 1878 sold the said property to a certain Daniel Moriarty at and for the sum of seven hundred and fifty dollars and the object of this deed is to convey the said property to the said Daniel Moriarty subject to a Mortgage from the said Moriarty to the said Administrator for the purchase money therefor, and which Mortgage is of even date herewith.

Chew Jones, Administrator as aforesaid, or to his assigns or successors, within twelve months from the 27th day of March A.D. 1878, the said sum of seven hundred and fifty dollars, with interest therein from said last named date, the said debt and interest to be paid in the following manner, that is to say: The entire amount to be paid in trippages of not less than twenty five (\$25.00) dollars at each trip, and the entire indebtedness to be paid within twelve months from the 27th day of March A.D. 1878, and upon the payment of said indebtedness, This Mortgage shall be absolutely null and void, else to be and remain in full force and virtue in law, and the said Daniel Moriarty for himself, his heirs and representatives covenants with the said R. Chew Jones, as Administrator aforesaid, and with his assigns and successors, that he will pay the aforesaid amount of money with interest as aforesaid, in the manner and within the time hereinbefore specified.

<u>And upon</u> the first default in any of said payments at the time and times hereinbefore stipulated, it shall be lawful for the said R. Chew Jones, Administrator as aforesaid, or his assigns or successors, to take possession of all and singular the aforesaid property, and to sell the same

either at private or public sale for cash or upon a reasonable credit, for the purpose of paying the mortgage debt and the costs and expenses attending said sale.
