PREFACE

Clifford Charles Swain gave the Chesapeake & Ohio Canal National Historical Park (C&O Canal NHP) five oral histories, in 1965 and 1973. Those have now been transcribed into electronic form; the oral histories are available on CDs from the C&O Canal NHP and the transcriptions are also available in both printed and electronic form from the C&O Canal NHP. After the oral histories were transcribed, Clifford's youngest son, Richard Lee Swain and his wife, Patricia Ann Swain, listened, in 2009, to each of the recordings of his father to provide the best "ear" to preserve the dialect and accent of Clifford C. Swain. (Note: This dialect is specific to people who lived and worked on the C&O Canal and in and around the Potomac River area in Washington County, MD. The Benjamin Swain family also had a significant local dialect. Only recent generations have lost most of this dialect.)

Clifford's older brother, Robert D. Swain, married Mary Thomas (Mamie) McKelvey who also gave the C&O Canal NHP an oral history, Sept. 1973. Their daughters, Genevieve Swain DeLauney and Juanita Swain Renner listened, in 2009, to their mother's recording for the same purpose.

Subsequently an effort was undertaken to verify Clifford C. Swain's memories with the participation of Richard and Patricia Swain. Not only did the effort resolve questions of spelling in the several oral history transcriptions but evolved into a Swain Family History.

Tables of vital statistics are provided at the end of this story. The tables were initially built from census data. Then as subsequent census reports provided different data, the tables were revised. When obituaries, family bibles or tombstones were found, the data was again refined. Thus the data in the tables is believed to be the most accurate. The correspondents supporting this effort are highlighted in yellow. Swain family members we have identified as canal boatmen are highlighted in light blue.

Readers will occasionally find information on persons in the family but not related to this history, e.g. Newton Ausbury Swain. They are included to help other Swain family researchers.

All canal photographs are courtesy of the Chesapeake and Ohio Canal National Historical Park while the family photographs were from the Richard Lee Swain Collection, unless otherwise footnoted.

The 1850 census listed Wm. Swain, age 38, living in Subdivision No. 2, Washington County, Md.¹ Living with him were: Martha, age 19, wife [they had married on April 5, 1845]; Mary Swain, age 3, daughter; and George, age 1, son. William Swain and Martha Smith were married by Rev. Conrad at St. John's German Lutheran Church, Hagerstown, April 5, 1845. Their son George William Swain married Frances Eugenia Kidwell, daughter of John W. Kidwell (1831 – 1902), boatman and bridge keeper of Shepherdstown, WV.

Emma C. Swain, daughter of William and Martha Swain, died on Sep. 10, 1855, aged 4 years, 3 months, 25 days. She was buried in Salem Lutheran Church Cemetery, Bakersville, Md.

The 1850 census reported George H. Swain, age 30, a Laborer, living in Subdivision No. 2, Washington County, Md.² Living with him were: Elizabeth, age 27, wife; James, age 9, son; John, age 6, son; and Martha, age 0, daughter. The son, James, later was listed as Frank; Martha was born on Aug. 25, 1849 and was thus just less than one year old.

The 1850 census reported John T. Swain, age 30, an engineer, living in Bladensburg, Md.³ Living with him were: Elizabeth E., age 22, wife [they had married on Jan. 8, 1847]; Trepheinia, age 3, daughter; John P.[T], age 1, son; and William E. Dorsey, age 22, relationship not recorded, a laborer. The daughter, Trepheinia, must have died prior to 1860; at least no further records of her have been found.

The 1850 census reported Samuel Swain, age 24, a laborer, living in Washington County. Living with him were: Sarah, age 22, wife [they had married on Jan. 11, 1848]; and Ann, age 1, daughter.

The 1850 census listed Benjamin Swain, age 28, a laborer, living in Washington County.⁵ It appears that he and seven other men laborers were all living in a house with Margaret Bickley, age 40, a single mother, and her five children.

The 1850 census listed Samuel Boyer, age 37, a miller, living in Subdivision No. 2, Washington County, Md.⁶ Living with him were: Minerva, age 22, [they had married on April 6, 1850] second wife; Susan, age 16, daughter [she subsequently married Benjamin Swain, Sr. on June 22, 1851]; Samuel, age 13, son; Margaret, age 11, daughter; Juliana, age 10, daughter; Virginia, age 8, daughter; and Mary, age 4, daughter. All these children were by Samuel Boyer's first wife, Elizabeth Dun-a-wha, a Native American, from Ilinois.

Anne Amelia Swane [Swain], daughter of Samuel and Sarah Swain, died on Oct. 6, 1852, aged 4 years, 10 days. She was buried in Mt. Calvary Lutheran Cemetery, Sharpsburg, Md.

The 1860 census listed George Swain, age 46, a Laborer, with real estate valued at \$300 and a personal estate valued at \$75, living in Sharpsburg.⁷ Living with him were: Elizabeth, age 39, wife; Frank, age 20, son, a Boatman; John, age 17, son, a Boatman; Martha, age 10, daughter; and Charles, age 3, son.

The 1860 census reported John T. Swain, age 40, a laborer with real estate valued at \$200 and a personal estate valued at \$50, living in Sharpsburg. Living with him were: Elizabeth, age 35, wife; John, age 10, son; Elizabeth, age 9, daughter; Charles, age 8, son; Ellen, age 5, daughter; Virginia, age 3, daughter; and William, age 1, son.

The 1860 census also reported Samuel Swain, age 41, a Boatman, with real estate valued at \$300 and a personal estate valued at \$75, living in Sharpsburg. Living with him were: Sarah, age 34, wife; Fanny, age 5, daughter; and Hiram, age 3, son.

The 1860 census listed Benjamin Swain, age 30, a Boatman, with a personal estate valued at \$50, living in Sharpsburg, Md. Living with him were: Susan, age 25, wife; Isabella, age 8, daughter; Samuel, age 5, son; and Emily [sic. Emma Traphenia?], age 2, daughter. Their son, Charles Reuben Swain, has been born and died in 1853.

The Civil War started on April 12, 1861.

William Swain died on Nov. 23, 1861 and was buried in Keedysville. [Believed to be the William Swain who married Martha Smith in 1845 and had, Mary, George and Emma.]

Benjamin Swain, age 41, Boatman, registered for the Civil War Draft; he was living in Sub-District No. 24, Tilghmanton, Md. Prior to the draft, Benjamin Swain, Sr., was captured in his front yard by the Union Army. He was thought to be a Confederate spy. His wife, Lizzie, was baking bread that morning. He was held for three days before he was released. He later served for a short time (the Hundred Days' recruits?) in the Union Army.

John W. Swain, age 19, enlisted as a private on Aug. 12, 1862; he was transferred on Apr. 8, 1865 to Company H, Maryland 13th Infantry Regiment; he was mustered out on May 29, 1865 at Baltimore, Md. as a private.

The Civil War ended on April 9, 1865.

The 1870 census reported Samuel Boyer, age 57, a Forwarding Merchant [i.e. forwoding mercout, French translation, ferryman over short water] with real estate valued at \$14,000 and a personal estate valued at \$21,000, living in Bakersville, Md. Living with him were: Minerva, age 42, wife; William H., age 19, son; Charles E., age 14, son; Nanny A., age 9, daughter;

Edmonia, age 7, daughter; Isaac M., age 5, son; Thomas J., age 2, son; and a female domestic servant. All these children were by Samuel's second wife, Minerva McCoy of McCoy's Ferry family.

The 1870 census listed John T. Swaine, age 48, Boating on the Canal, with real estate valued at \$200 and a personal estate valued at \$600, living in Sharpsburg. Living with him were: Elizabeth, age 43, wife; John T., age 21, son, Boating on Canal; Charles H., age 17, son, Boating on the Canal; Ella, age 14, daughter; Virginia, age 12, daughter; William F., age 10, son; Ida F., age 6, daughter; Abbie, age 4, daughter; and Jesse A., age 8/12, son.

The 1870 census also listed Samuel Swaine, age 49, Boating on the Canal, with real estate valued at \$500 and a personal estate valued at \$100, living in Sharpsburg. Living with him were: Sarah Swaine, age 34, wife; Fannie, age 16, daughter; Hiram, age 14, son; and William H., age 6, son.

The 1870 census also reported John W. Swaine, age 26, Boating on the Canal, with a personal estate valued at \$600, living in Sharpsburg. Living with him were: Georgiana, age 20, wife; and Charles E., age 4, son.

In 1870 Henry Thomas Weld sold to Thomas Donnelly the canal boat *S. S. Cunningham.*¹⁶ This is of interest, because in 1873 Charles Henry "Hen" Swain and Frisby Renner borrowed \$400 from Samuel Johann Boyer, ¹⁷ to buy the four mules (Duckett, Sis, Patrick and Beck) with their rigging from the *S. S. Cunningham.*¹⁸ Presumably Charles Swain needed the mules and rigging for his canal boat. Samuel J. Boyer was the father-in-law of Benjamin Swain, Sr., and the father of Elizabeth "Lizzie" Boyer Swain whose mother was Native American Elizabeth Dun-a-wha. Elizabeth was brought from Niantic, Illinois, Northwest Territory to Hagerstown, Md. by a Hershberger family. The Boyer and Hershberger families are found to be neighbors in the census in south Hagerstown. Both families attended St. John's Lutheran Church on South Potomac Street. Elizabeth was baptized at the age of five. Her birth name was Colloneneeskee Chashetstah DUN-A-WHA, [i.e. later Elizabeth Hershberger]. She is buried in the Salem Evangelical Lutheran Church Cemetery in Bakersville, Md. with her Indian name, Elizabeth Dun-a-wha Boyer, on the tombstone.

In August, 1870 we read: "Child Drowned - A child aged about 5 years, son of John Whittington, was drowned in the C. & O. Canal, near Mercerville, a few days ago. A jury was empaneled by Mr. Samuel Boyer, who rendered a verdict of accidental drowning." Based on that article, it seems that Samuel Boyer was a Justice of the Peace, Washington County in 1870.

During the decade of 1870, canal boats named after family members made the following number of trips from Cumberland to Georgetown or Alexandria, carrying coal:

Of note is that most of these boats were captained by other Sharpsburg residents; Capt. Grove took the canal boat A. M. Grove most of the time, 1875 - 1878. Capt. Spong took the canal boat Isaac M. Boyer, a son of Samuel J. Boyer, all 10 times in 1877. And, William H. Boyer did take the canal boat Minerva Boyer on 9 of its 10 trips in 1877.

On April 2, 1872, William H. Boyer, age 21, married Martha A. Mose, age 19, in Sharpsburg, Washington County, Md.²⁰

The canal boat *William Hill* was registered on 3/1/1873 as owned by John Swain, Sr., of Sharpsburg.²¹ The boat made 7 trips in 1873, 9 trips in 1874 and 3 trips in 1875, presumably with Capt. John Swain, Sr., but the records do not indicate the captain's name.

In 1876, a Capt. Swain took the canal boat Wm. Hill on 14 of 15 trips, with Capt. Grove taking her on the one other trip. Also in 1876, a Capt. Swain took the canal boat A. F. Lantz on 15 of 15 trips; F. F. Davis on 7 of 7 trips. And in 1876 the S. S. Howison made 11 trips with a Capt. Swain, for the American Coal Company and one trip for the Consolidation Coal Company, presumably with Capt. John T. Swain.

The next record we have found of John T. Swain, was in the 1878 Boat Register²² wherein the canal boat *S. S. Howison* was captained by John T. Swain, owned by American Coal Company, built by Doerner & Bender in 1872 and employed by American Coal Company. From a newspaper of the same year, 1878,²³ we find:

Daily Alleganian and Times, Cumberland, MD, newspaper, 1878.

The first three trips appear normal, taking about 17 days for the round trip; suggesting normal daylight operations. The June 22 to July 24 round trip was 32 days. The same newspaper reported the *S. S. Howison* arriving in Alexandria on July 10 and departing on July 11. That would mean 18 days to descend and 13 days to ascend, which was not a very fast pace. Then the July 24 to Sept. 18 round trip was 56 days. During that trip the same newspaper reported: the water was drawn off at Seneca to repair a lock gate; heavy rains damaged two culverts which had to be repaired; a canal boat got imbedded in the silt washed down with the heavy rains into Rock Creek closing navigation; American Coal Co. suspended shipments of coal from Cumberland to Alexandria owing to the large stock on hand at their wharves in that city; there was a break at the log wall; and navigation was interrupted due to repairs on an Aqueduct. The *S.S. Howison* arrived in Alexandria on Sept. 9th and departed the same day. That was 47 days to descend and 9 days to ascend. The remaining three trips averaged 20 days per round trip, 13 days to descend and 7 days to ascend, on average.

John T. Swain, Sr., born 1820, had a son, John T. Swain, Jr. born 1848. So, when we look in the 1878 Boat Register we find the canal boat *A. F. Lantz*, captained by John Swain and owned by John Swain, built by Consolidation Coal Company in 1874 and employed by Consolidation Coal Company, however, a Bill of Sale has not been found. John, Sr. would have been 58 years old and John, Jr. would have been 30 years old. The *A. F. Lantz* was probably owned and captained by John Sr. with John, Jr. being the captain for the *S. S. Howison* mentioned above; the 1870 and 1880 censuses list both as "boatman." From the same newspaper for 1878 we find:

The first four trips appear normal, taking about 19 days round trip; suggesting normal daylight operations. Then the July 18 to Aug. 22 round trip was 35 days. The interruptions to navigation mentioned above probably contributed to the long trip. However, since this Capt. Swain was freighting for Consolidation Coal Co. to wharves in Georgetown there was not a suspension of shipments. The remaining five trips averaged 15.6 days per round trip; a little faster pace but still daylight hours.

The 1878 newspaper also records canal boats named: W. M. Hill, F. F. [Frisby Frances] Davis and Wm. Young with Capt. Swain, freighting coal. The 1878 Boat Register does not list W. M. Hill or F. F. Davis as canal boats but rather canal boat captains. The 1878 Boat Register for the canal boat Wm. Young lists Capt. Charles Reeves as in charge. So, the identity of this other Capt. Swain is unknown, although we suspect it could have been Charles Henry Swain, per Mark Swain, this person was known as "Hen."

The next record we have found, in 1879, was an account of Baptism by Immersion: "Baptism by Immersion

On Thursday last at 2 P.M. quite a number of persons assembled in Rushville, about one mile west of town, on the Potomac River, to witness the baptism by immersion of twenty-one candidates who had made application for admission into the denomination known as the Wmebrennarian [sic, Winebrenner], or Church of God. The exercises consisted of the singing of a hymn, followed with prayer, and an address by the pastor, Rev. S. W. Naill. The mode of baptism is as follows. The candidate is led into the water and immersed once backward in the name of the Father, Son and Holy Ghost. The following are the names of those who were baptized: W. H. [William Henry] Boyer and wife [Martha Ann Mose Boyer], John [William] Swain and wife [Georgiana Brashears Swain], . . Franklin Swain"²⁴

The 1880 census reported George Swain, age 63, Laborer, living in Sharpsburg.²⁵ Living with him were: Elizabeth, age 58, wife; Martha, age 30, daughter; and George, age 19, son, Laborer.

The 1880 census reported Samuel Swain, age 57, Farm Laborer, living in Tilghmanton District.²⁶ Living with him were: Sarah, age 52, wife; W. H., age 15, son; and Hiram, age 22, son.

The 1880 census reported Benjamin Swain, age 56, a farm worker, living in Tilghmanton, Md.²⁷ Living with him were: S. Elizabeth, age 44, wife; Samuel L., age 24, son, works on a farm; Emma, age 21, daughter, domestic; Benjamin, age 14, son, works on farm; Charles L., age 11, son; and James E., age 9, son.

The 1880 census listed John W. Swain, age 36, Boatman, living in Sharpsburg.²⁸ Living with him were: George Ann, age 32, wife; Charles E., age 14, son, works on boat; Bertha A., age 8, daughter; Edna C., age 4, daughter; and Harvey V., age 1, son.

The 1880 census reported William H. Boyer, age 29, Laborer, living in Sharpsburg.²⁹ Living with him were: Martha A., age 27, wife; Clarence N., age 7, son; Nannie L., age 5, daughter; Harry M. C., age 2, son; and John S., age 6/12, son.

We find that Capt. John Swain captained the canal boat J. P. Hewitt in 1887 as follows:³⁰

All the coal was consigned by Consolidation Coal Co., excepting only the 9/30/1887 load. The trips appear to take at least ten days, usually longer, suggesting only daytime freighting. That same year, 1887, a Capt. Swain captained the canal boats: H. Roussel 12 trips, Fred Williams once, Allan Campbell 6 trips, James E. Dyer & Bro. once and Elbe River 9 trips. We haven't found which Capt. Swain captained which canal boat.

On Feb. 23, 1889, Charles E. Boyer had the adjacent studio portrait made.

On Jan. 20, 1890, William H. Boyer was appointed U. S. Postmaster for Sharpsburg, Md. and remained at that post until July 5, 1892.³¹

Samuel Swain died on Apr. 3, 1890. His obituary read: "**DIED** – SWAIN – On Thursday night, April 3, at his home in Sharpsburg, Mr. Samuel Swain, aged 68 years, 4 months and 22 days."³² A week later the newspaper reported: "Tuesday, April 15, 1890 – Letters of administration on the personal estate of Samuel Swain, deceased, granted unto Charles S. Wade.³³

George H. Swain died on Dec. 11, 1890. His obituary read: "**DIED** – SWAIN – On Thursday, December 11, at Sharpsburg, at his home, Mr. George H. Swain, aged 71 years, 5 months and 23 days."³⁴



In 1891, we have the death of Samuel Johann Boyer reported:

"Death of Samuel Boyer. - Mr. Samuel Boyer died at ten o'clock last Friday night at his residence near Mercerville. His illness was of brief duration - not over twenty-four hours; death resulted from a severe attack of cholera morbus. Mr. Boyer was a native of Virginia, and was born December 29, 1813. He was therefore, 77 years, 5 months and 13 days old. He was twice married, and was the father of fourteen children, seven by each wife. Two of his first wife's children are dead. His other twelve children survive him, and they are all married but a son, Thomas. They are Mrs. Elizabeth Swain, W. H. Boyer, Mrs. Ettie Brashears, Isaac M. Boyer, of Sharpsburg; Samuel W. Boyer, of California; Mrs. Margaret Mongan, Thomas J. Boyer, Mrs. Mollie C. W. Heck, of Bakersville; Mrs. Ellen Knode, Mrs. Virginia Harper, Charles E. Boyer, of Mercerville, and Mrs. Nannie A. Whittington, of Roanoke, Va. Mr. Boyer lived in this county for



sixty years. Before the war, he was engaged in buying and selling flour, corn, etc., in partnership at different times with Messrs. Watson & Emmert. Since the war, he was a grain merchant at Mercerville, until within the last few years. He was also a justice of the peace and road supervisor for a number of years. He was a Whig until the outbreak of the war, when he became a Republican and was identified with the latter party until his death. He was also a member of the Church of God. His funeral occurred Sunday afternoon. Services were conducted at the church at Bakersville, where his remains were interred."³⁵



The adjacent photograph was taken late in his life.

The John T. Swain, Sr. family had some financial difficulties; they were unable to pay the 1888, 1889, 1890 and 1891 State and County taxes. Then John Swain had a stroke, reported in the newspaper:

"Mr. John T. Swain, of Sharpsburg, suffered a stroke of paralysis on his canal boat recently, a few miles below Williamsport. He is seventy years old and has been a boatman ever since the canal has been in operation."³⁶

The home was sold at Public Auction to Aaron C. and Annie Pry. On March 17, 1893, the Circuit Court of Washington County proceeded to ratify and confirm the sale on April 14, 1893.³⁷ Later in 1893 we read: "Mr. John Swain, Sr., is quite ill with little hope of recovery."³⁸

And then the obituary:

"Death of John Swain

Mr. John Swain died in Sharpsburg on Wednesday from the effects of paralysis. He resided on Chaplain Street and was over seventy years old. The deceased was well known and for many years was a canal boatman. Several years ago, he was paralyzed and has been in feeble health ever since. The deceased leaves a wife and a large family of children, all grown. Funeral Friday afternoon at 2 o'clock."³⁹

In 1895, Charles Luther Swain married Cora Elizabeth Colbert. The adjacent studio photograph may well be their wedding photograph.

"The same rains which caused the historic Johnstown Floods of June 1889 left the canal a total wreck. The canal company was unable to raise sufficient funds to repair the canal and found it necessary to declare bankruptcy. The Baltimore and Ohio Railroad (as the major bondholder) offered to restore the canal, knowing that a railroad competitor was likely to buy the canal if there was a forced sale. The Maryland Circuit Court for Washington County at Hagerstown, Maryland, authorized the B. & O. Railroad to complete repairs and to operate the canal as a 'last ditch' effort. The railroad completed repairs to the canal in 1891 and it was back in operation in 1892. The receivers then organized a subsidiary corporation, the Canal Transportation Company, as a device to enable the canal (through funds received from the railroad) to show a profit each year as required by the court order. The new transportation company agreed to provide any additional boats required and to keep the canal navigable. The contract, dated 1894, went into effect on 1 January 1896."⁴⁰ Thus by the time Clifford C. Swain went on the canal, the canal was in the receivership period. Clifford Swain remembered going on the canal in 1895 at about 6 years of age. 41 He also remembered starting to drive mules when he was about 10 years old. At this point it is appropriate to insert some historical photographs taken on the canal in the area of Snyder's Landing. The photograph below is of an unidentified canal boat family tied up



on the berm side of the canal; that white building visible through the trees is the store/warehouse at Snyder's Landing. We suspect the family swimming in the canal, shown below, is the same


family. The boat looks to be Canal Towage Co. Boat No. 42.

The Benjamin Swain, Jr., Howard Milton Swain and Boyer family farms were located along the canal/river between Snyder's Landing and Boyer's Landing (now called Taylor's landing). There are related families still living in the area. Marcellus relates he went to Snyder's Landing and watched the men pull his cousin, George Richard Poffenberger, a teenager about 14 years old, out of the canal. He had fallen in and drowned in 1930. Marcellus said George got his foot caught on a rock and couldn't get loose. Very few canal people could swim.

For a light boat ascending the canal the view would be as shown adjacent. Notice the suspension bridge across the canal. The town of Sharpsburg, where the Swain family lived, was to the right. Canal mothers would bring clean clothes and a hot meal to their families by crossing the suspension bridge to the towpath, on the left, where the packages could be passed up to her husband and son(s) without the boat coming to a full stop. If feed or other supplies were needed the suspension bridge gave access to the store on the berm side. When a light boat wanted to carry a back load to Cumberland it could pull over on the berm side, tying up right at the



warehouse where bulk quantities or sacks of grain or other agricultural products, e.g. bales of hay could be loaded.



The Canal Company required a 14' clearance between the water surface and the lowest portion of any overhead structure. With a light boat and the awning up, as shown in the adjacent photograph, the requirement was continued by the receivers.

Notice the flags flying from the front of the foreword cabin. These were a help to the steersman in keeping the bow of the boat away from the berm bank.

Also notice the stockpiled coal on the far side of the warehouse; the coal for sale to Sharpsburg citizens.

The adjacent photograph is of the suspension bridge stairs and landing on the towpath side, actually the towpath also goes under the suspension bridge. Walking down from Sharpsburg to view the passing boats was an outing for the family.

The widow, Elizabeth E. Swain, still had financial difficulties. In July 1896, she bought the home place back from Aaron and Annie Pry for \$85⁴² but also had to mortgage that home place for \$260.⁴³ The mortgage was released on Feb. 12, 1904.⁴⁴

During July 1897, Annie Swain was instrumental in saving the life of Mr. Frisby T. Staubs, who attempted

suicide as related in a newspaper article attached at the back of this report.




Circa 1899, the Benjamin S. Swain, Jr. family posed for the adjacent photograph. Identified left to right: Benjamin, Elmer Lester, wife Margaret A., baby John Luther, Howard M. and an unidentified male in the shadows.

The 1900 census reported John W. Swain, age 56, widowed, a Boatman, living on Chaplin street, Sharpsburg.⁴⁵ He was living with Benjamin Highberger, age 34, son-

in-law; Edna S., age 24, daughter; and Harvey V. Swain, age 22, son.

The 1900 census reported William H. Boyer, age 49, a Boatman, living in Sharpsburg, Md. ⁴⁶ Living with him were: Martha A., age 47, wife; Clarence N., age 27, son, a Boatman; Nannie L., age 25, daughter; Harry L., age 22, son, a Farm Laborer; John S., age 20, son, a Bill Clerk;



Charles M., age 18, son, a Boatman; Thomas, age 15, son; Eva, age 11, daughter; Bessie, age 8, daughter; Martha, age 6, daughter; William H., age 3, son; and Mary J. Mose, age 68, mother-in-law.

The 1900 census listed Benjamin Swain, [Jr.], age 30, a Farmer, living in Tilghmanton, Md.⁴⁷ Living with him were: Margaret A., age 28, wife, who had 3 children and all were then still living; Elmer, age 9, son; Howard M., age 7, son; John L., age 1, son, and Susan E. age 65, mother, who had 11 children, 6 of whom were then still living.

Circa 1905, the adjacent photograph of the Charles L. and Elizabeth C. Swain children, from left to right: Myrtle, Pearl and Hugh, was taken in a studio.

In 1906 Robert D. Swain married Mary Thomas (Mamie) McKelvey.

That same year a newspaper reported: "WASHINGTON BOY DROWNED. - Was Mule Driver on William Swain's Canal Boat. - CUMBERLAND, Md., June 28. - The body of Humphreys Davis, aged sixteen years, of Washington, D. C., was found floating in the Chesapeake and Ohio canal Tuesday afternoon, just below Oldtown. Coroner George Martz went to Oldtown and made an investigation yesterday. The drowning, it is thought, was the result of accident. Davis was in the employ of William Swain, of Sharpsburg, who runs a canal boat, as mule driver. As the boat of Swain was being taken through the lock Sunday night Davis was missed. Swain said he could not account for the sudden disappearance of the boy unless he ran away. Nothing further was thought of the matter until the discovery of the body. The boy has an aunt in Washington, D. C. His body was interred at the cemetery in Oldtown yesterday.

"There is some criticism of Swain for not looking more into the sudden disappearance of the boy. From what persons who were about the lock at the time say, the boy, while no one saw him fall into the water, must have walked right in, through a gate left open, but was thought to have been closed. Relatives in Washington will be hunted up by the canal authorities." 48

Later that same year James Franklin Swain died; his obituary read:

"Franklin Swain, a well-known resident of Sharpsburg, was found dead in bed at 7 o'clock Friday a.m., by his wife. He had been dead for several hours. Death was sue to a stroke of paralysis. Mr. Swain was paralyzed 13 years ago and had been an invalid since and was only able to go about in a wheelchair.

"He had formerly been a boatman on the canal and was a member of the Lutheran church.

"He is survived by his wife and several sons and daughters.

"Funeral Sunday at 4 o'clock; interment in Mountain View Cemetery." 49

The Benjamin Swain Jr. family farm was near Sharpsburg; the family gathered circa 1908 for the following photograph.:⁵⁰ They are identified, left to right, as: son Howard Milton Swain, son John Luther Swain, mother Elizabeth Boyer Swain, son Raymond Emanuel Swain, wife Margaret Poffenberger Swain, Benjamin Samuel Swain, Jr., and son Elmer Lester Swain.

In 1908, the newspaper reported the death of Clifford Swain's mother:

"Death of Mrs. Swain

Mrs. Annie Swain, wife of Henry Swain, a boatman on the C. & O. canal, died Sunday morning at her home, Sharpsburg, from paralysis, aged about 45 years. Mrs. Swain was stricken while on her husband's boat Saturday morning, and was unconscious nearly all the time up to the time of her death. She was a native of Sharpsburg and was a member of the Lutheran church. Surviving are her husband and eight children."⁵¹

Clifford Swain remembered leaving the canal in 1909 when he was 19 years old.⁵² At the time he hated life on the canal, he wanted to do something else. Years later he realized life on the canal was an easy life but he did not regret leaving as he bettered himself, picked up some education, had some good jobs and raised his family.

In 1910 Charles H. Swain and family were living on Antietam Street in Sharpsburg, MD. ⁵³ He was a widower; his occupation was reported as Laborer, Boatman C & O. Son, Lloyd H. Swain, age 25, had the same occupation while son, Clifford C. Swain, age 19, had his occupation reported as Laborer, Dying Mill (he had already left the canal). Daughter, Mamie F. Swain, age 17, was running the household; daughter Grace M. Swain, age 13, and son Leonard Swain, age 11, were presumably going to school.

The 1910 census reported William H. Boyer, age 59, a C. & O. Canal Boatman, living in Sharpsburg. Living with him were: Martha A., age 57, wife; Nannie L., age 35, daughter; Charles M., age 27, son, a C. & O. Canal Boatman; Edna J., age 21, daughter; Bessie L., age 18, daughter; Martha M., age 16, daughter; and William H., age 13, son.

The 1910 census reported Benjamin Swain, age 43, a Farmer, living in Downsville.⁵⁵ Living with him were: Margaret A., age 38, wife, she had 4 children all of whom were then still living; Elmer L., age 19, son, working on home farm; Howard M., age 17, son, working on home farm; John L., age 11, son; Raymond E., age 4, son; and Susan E., age 75, mother, she had 11 children of whom 6 were then still living.

The adjacent photograph of Charles Henry Swain was taken in Dec. 1912. In 1912 Clifford C. Swain married Helen Forrest DeLauney and Marjorie Cliffordene Swain was born on June 26, 1916.

On Sept. 29, 1913 a newspaper reported:

"Lock Tender Found Drowned in Canal "Floating in the lock which he had tended for many years, the body of John Swain, [Jr.] sixty years old, keeper of No. 14 lock, of the Chesapeake and Ohio canal, was found yesterday. How the aged man was drowned nobody knows. It is believed, however, that Swain, whose station is at the head of the seven locks, a short distance above Cabin John, got up during the night to attend to something about the canal, lost his balance, and fell overboard. An investigation by the coroner resulted in a certificate of accidental death being issued." Another newspaper had the following story: "Missed by his wife when she went to his room to call him to breakfast, the body of John Swain, veteran keeper of

Lock No. 14 of the Chesapeake and Ohio Canal, early yesterday morning was found floating in the canal a hundred feet below. How Swain was drowned no one seems to know.

"It is thought that during the night Swain went out to turn the water into the lock, and accidentally fell. His watch had stopped at "12:50" o'clock.

"Shortly after 6:30 Mrs. Swain went to her husband's room. Not finding him there she searched in other parts of the house. Alarmed at her failure to find him, she went to Lock No. 12 several hundred yards below, and asked Keeper Stephenson whether her husband had been there. Together Mrs. Swain and Stephenson began a search for the veteran keeper. His body was found floating in the canal, not far from his home." 57

Circa 1915, Hugh L. Swain would be 20 years old and had the adjacent studio photograph taken.

World War I came along and men had to register for the draft, including:

Harvey Vister Swain, born Jan. 31, 1878, then living at 233 Virginia Ave., Cumberland, Md.,

and working as a Steel Worker for N. & J. Taylor, Cumberland, Md. ⁵⁸ His nearest relative was Minnie Swain of the home address. He was tall in height, stout of build, with blue eyes, and brown hair.

Newton A. Swain, born July 22, 1873, then living at 344 South Second Street, Dauphin, Pa., and working as a Laborer at B. S. Co., Steelton, Pa.⁵⁹ His nearest relative was Mrs. Clara Swain, of the home address. He was of short height, medium build, light blue eyes, and dark brown hair. He had already served in the Army from 6/28/1898 until 4/10/1899, during the Spanish – American War, and was discharged as a Private, 2nd Regiment, W. Va. Infantry. and died 4/11/1948, he was buried in Baldwin Cemetery, Steelton, Pa.⁶⁰ He was apparently married twice: the first marriage was to Anna Margaret **Cormany**, b. 1868, d. 1916, and then to Clara -----, whom he married on Sep. 8, 1917, days before he registered for the draft. They had one child, Newton Ausbury Swain, Jr., b. 1921, d. 2000.

Robert Swain, born Nov. 27, 1879. then living in Williamsport, Md. and working as a Laborer at Keystone Lime Stone Co., Hinesburg, Pa. ⁶¹ His nearest relative was Mamie Swain, [wife], Williamsport, Md. He was short of height, stout build, blue eyes and black hair.

Lloyd H. Swain, born May 1884, then living at 420 Salem Ave., Sharpsburg, Md. and working in his own store, restaurant on Salem Ave.⁶² His nearest relative was Henry Swain, Sharpsburg, Md. He was short of height, stout build, blue eyes and light hair.

Clifford Charles Swain, born June 4, 1890, then living at 512 W. Church St., Hagerstown, Md. and working as a Travelling Machine Erector for Pangborn Corp. ⁶³ He was married with a wife and child. He was medium of height, medium of build, blue eyes and brown hair. Because he was married with one child, he was exempted from service.

Leonard Swain, born Oct. 26, 1899, then living at Virginia Ave., Hagerstown, Md. and working for the Western Maryland Railroad Co., Hagerstown, Md. His nearest relative was Annabell Swain [an older sister b. 1882] of Virginia Ave. Hagerstown, Md. He was of medium height, stout build, with blue eyes and light hair.

Bertram Earl Swain, born May 17, 1892, then living in Sharpsburg, Md. and boating on the C. & O. Canal for his father [William F. Swain]. He was single with a child. He was of medium height, medium build, with blue eyes and light brown hair.

Clyde Elias Grove, born May 20, 1879, then living in Sharpsburg. Md. and was boating on the C. & O. Canal.⁶⁶ He had a wife living in Sharpsburg, Md. He was of medium height, medium build, with blue eyes and black hair.

Oliver Murphy Grove, born April 20, 1881, then living in Sharpsburg, Md. and working as a Boatman on the C. & O. Canal, out of Washington, D. C.⁶⁷ His nearest relative was Lulu Grove (Wife), of Sharpsburg, Md. He was of medium height, slender build, with blue eyes and black hair.

John Thomas Murphy, born June 3, 1888, then living in Sharpsburg, Md. and working at Remington Guns Co., Eddystone, Pa.⁶⁸ He was single and supporting his mother [Virginia F. Swain Murphy]. He was of medium height, medium build, with gray eyes and dark brown hair.

Bertram Earl Swain, born May 17, 1892, then living in Sharpsburg, Md. and working for his father, boating on the C. & O. Canal. He was of medium height, medium build, with blue eyes, light brown hair and not bald.⁶⁹

John David Bell, born Apr. 29, 1885, then living at 1245 22nd St. NW, Washington, D.C. and working as a foreman at the Treasury Dept., Washington, D.C.⁷⁰ His nearest relative was Annie G. Bell [mother], of the same address. He was of medium height, medium build, with gray eyes and light brown hair.

Charles Edward Swain, born Jan. 14, 1892, then living in Williamsport, Md., and working as a Laborer at W. D. Bynum & Sons. ⁷¹ He was married with two children. He was short in height, slender in build, with blue eyes, light hair, and not bald.

Elmer Lester Swain, born Mar. 18, 1891, then living in Sharpsburg, Md., and farming for himself in Downsville, Md..⁷² He was married. He was medium in height, stout in build, gray eyes, light hair and not bald.

Howard Milton Swain, born Nov. 25, 1893, then living on Route 1, Sharpsburg, Md., and farming for his father at the same address. He was single. He was tall in height, medium in build, blue eyes, light hair and not bald.

John Luther Swain, born July 19, 1898, then living on Route 1, Sharpsburg, Md., and farming for his father, Benjamin Swain.⁷³ His nearest relative was Margaret Swain of the home address. He was medium in height, medium in build, with brown eyes and brown hair.

1918 was the year of the Spanish flu which killed millions of people world-wide and in the U. S., about 28% of the population became infected, and 500,000 to 675,000 died. The highest mortality rates were among the young adults. Two of which were Helen Forrest Swain and her second daughter Virginia DeLauney Swain. Clifford was heartbroken and unprepared to raise an infant while maintaining a job. The solution was to send Marjorie C. Swain to live with her grandparents, Mr. and Mrs. Thomas DeLauney, in Sharpsburg.

The 1920 census reported John W. Swain, age 76, widowed, living on Mechanic Street, Sharpsburg.⁷⁵ He was living with: Benjamin Highberger, age 54, son-in-law; Edna S., age 44, daughter; and four servants.

The 1920 census reported [Charles] Henry Swain, 67 years old, widowed, no occupation, living on Antietam Street (census dwelling #1), Sharpsburg, MD.⁷⁶ The same census reported Clifford

Swain, 29 years old, widowed, as a Roomer with the William A. Bears family on West Washington Street, Hagerstown, MD.⁷⁷ His occupation was reported as a Machinist, Railroad.

The same census reported Thomas Clay and Laura Belle (Fisher) DeLauney as living on Antietam Street (census dwelling #21), Sharpsburg, MD, with: son Mervin Thomas, age 21; daughter, Mary Savilla, age17; son, Lloyd W., age 14; granddaughter Margery Cliffordene Swain, age 3-6/12; and father-in-law, John W. Fisher, Sr., age 81 and widowed.⁷⁸

Then in Potomac, Montgomery County, MD the 1920 census listed Jessie Anderson Swain, 49 years old, widowed, living on River Road, occupation: Lock Tender, Canal [Lock 21]. This would have been [Charles] Henry Swain's youngest brother, and uncle to Clifford C. Swain.

The 1920 census also listed Benjamin Swain, age 53, a Farmer, living in Sharpsburg. ⁸⁰ Living with him were: Margaret, age 48, wife; Howard, age 27, son, working on home farm; John, age 21, son, working on home farm; Raymond, age 14, son; and Inez, age 28, daughter-in-law.



By 1920 the children of Charles L. and Elizabeth C. Swain were all grown up and had a studio portrait taken, as shown to the left. Identified, left to right: Myrtle E., Hugh L. and Pearl L. Swain.

In 1922, William H. and Martha A. Boyer were living on Main street, Hagerstown; his occupation was Boatman. 81 Their son, William H. Boyer, Jr., had a residence on Main street and he was a conductor. Their son Charles M. Boyer, also had a residence on Main street and he was a clerk.

Sometime about 1923 Clifford Swain married Mary Savilla DeLauney, sister to Helen Forrest DeLauney. By then Clifford had a job at a shoe factory and was able to bring his daughter, Marjorie, to live with them. Son, Maxwell Leo Swain was born to the couple on May 3, 1924, followed by son, Alfred Eugene Swain on Nov. 3, 1929;⁸² and lastly a son, Richard Lee Swain on Oct. 19, 1936.

And that the man in the adjacent photo and the photo below do not look like the same person. Marcellus and his family also knew Charles Henry Swain. The adjacent photograph was taken of Charles Henry Swain ca. 1925. The photograph below was taken about the same

time.



John William Swain died on Mar. 16, 1925 and was buried in Mountain View Cemetery, Sharpsburg, Md. His obituary read: "JOHN W. SWAIN, aged resident of Sharpsburg, died at the home of his daughter, Mrs. Frank Highberger, in Sharpsburg yesterday. Death resulted from a complication of diseases. He was 81 years, two months and five days old.

"Mr. Swain was a lifelong member of the Lutheran Church of Sharpsburg and was one of the oldest members of Magnolia Lodge, Knights of Pythias, of Sharpsburg.

"He is survived by three sons, Charles, Sharpsburg; Harvey, Cumberland; and Rodney, Harrisburg; one daughter, Mrs. Frank Highberger, Sharpsburg; and one brother, George, of Sharpsburg; and six grandchildren and three great-grandchildren.

"Funeral services were conducted at the Lutheran Church of Sharpsburg; burial was in Mountain View Cemetery; pallbearers were members of the Knights of Pythias of Sharpsburg."83

William H. Boyer died on April 10, 1926 and was buried in Mountain View Cemetery, Sharpsburg, Md. His obituary remains to be found.

In May 1929 in **Sharpsburg Letter** we read: Mr. and Mrs. Elmer Swain and daughters, Edwina and Arvella, visited Mr. and Mrs. Benjamin Swain and brother Howard.⁸⁴

The 1930 census listed Benjamin Swain, age 63, a Farmer, living in Sharpsburg. Eving with him were: Margaret A., age 58, wife; Raymond E., age 24, son, a Farmer; Annie M., age 20, daughter-in-law; and Herbert Renner, age 20, a lodger, working as a farm laborer.

The 1930 census reported Clifford C. Swain, 39 years old, living on S. Cannon Avenue, Hagerstown, Md. where he worked as a laborer in a shoe factory. He owns the home, which has a value of \$2,600 and they own a radio set. Living with him were: Mary S., 28 years old, wife; (they married when he was 22 and she was 20 years old); Marjorie C., 13 years old, daughter; Maxwell, 5 years old, son; and Alfred E., 5/12 years old, son.

The 1930 census reported Jessie A. Swain, 58 years old, still living on River Road [in Potomac], then his occupation was School Bus Driver; the canal had closed in 1924 and he continued to live in the lock house [Lock 21] with: Otho, 27 years old, son; Attica, 18 years old, daughter; and Jessie A., Jr., 15 years old, son.

The 1930 census also reported Bertram C. Swain, age 38, working as a foreman at an electric plane, living on Back Street, Sharpsburg. Elwing with him were: Margaret M., age 32, wife; Mary M., age 10, daughter; Lottie V., age 7, daughter; Elwood L., age 5, son; Bertice E., age 3-5/12, daughter; Evelyn A., age 1-4/12, daughter; and William F. Swain, age 71, father.

From the **Downsville Letter** we read: Mrs. Benjamin Swain, Sharpsburg, was with the family of Lester Swain. And Mrs. Elmer Swain was on the sick list.⁸⁸ Then in April we read: Mrs. Benjamin Swain spent the week with her son, Elmer.⁸⁹ And in June we read: Edwina and Arvella Swain are spending the week with their grandparents, Mr. and Mrs. Benjamin Swain, Sharpsburg.⁹⁰

In August 1930, a newspaper reported:

"Mrs. Ella Grove - Mrs. Ella Grove, aged 75, died yesterday at 6:10 p.m. at her home at Sharpsburg.

She is survived by: Children, Mrs. Edward Mose, Mrs. Raleigh Bender, Clyde and Oliver Grove, Webber McGraw and Mrs. A. B. Delauney, Sharpsburg; brothers and sisters, Mrs. Elizabeth Cramer, Williamsport; Henry and William Swain, Sharpsburg; Mrs. Jeannie Murphy, Sharpsburg; Mrs. Thomas Bell, Keedysville; and Jessie Swain, Rockville.

The funeral will be held from the house on Monday at 2 p.m. by Rev. M. A. Ashby, pastor of the Lutheran church at Boonsboro. Interment in Mountain View Cemetery, Sharpsburg.

Note: Marcellus Swain was on the Mountain View Cemetery (Sharpsburg, MD) Board of Directors for several decades until 2013. Most of the local Sharpsburg families later in the 19th and the 20th centuries are buried in this "town" cemetery.

From the **Downsville Letter**, we read: Mrs. Blanche Boyer, Mr. and Mrs. Elmer Swain and family visited the family of Benjamin Swain, Sharpsburg.⁹¹

Mary Savilla Swain was the only surviving daughter of Thomas and Laura DeLauney, Sharpsburg. The Hagerstown newspaper had a Sharpsburg correspondent who reported on local

events. In those days, it was eventful when the Clifford Swain family came to Sharpsburg to visit her parents, which they did on Mar. 25, 92 April 8, 93 May 13, 94 Oct. 28, 1932, 95 and on June 2, 1933. 96 Perhaps the visits became so regular as to not be worth mentioning because the reporting of them was interrupted until April 7, 1939. 97 Although a newspaper did report that Mrs. Benjamin Swain of Sharpsburg was at the Irven home helping to care for Mrs. Irven. 98

In 1933 Clifford Swain's father died, the newspaper gave the following report:

"Charles Henry Swain died Saturday morning at 11 o'clock at the home of his daughter, Mrs. R. T. Staubs, 1111 Virginia Avenue, aged 81 years.

He was a retired boatman on the C. and O. Canal and was formerly from Sharpsburg. Surviving are: Daughters, Mrs. R. T. Staubs, this city; Mrs. Reuben Koontz, Johnstown, Pa.; Mrs. Oliver Crampton, this city; Mrs. Melvin Butts, this city; Mrs. Guy Stockslager, Downsville Pike, and Miss Lila Swain, this city; sons, Lloyd and Clifford Swain, this city; Robert Swain, Williamsport, and Leonard Swain, Sharpsburg; sisters, Mrs. Elizabeth Creamer, Williamsport; Mrs. Jenny Murphy, Sharpsburg, and Mrs. Abbie Bell, Keedysville; brothers, William Swain, Sharpsburg, and Jesse Swain, near Washington, D.C.

Thirty-six grandchildren and 12 great-grandchildren also survive.

The funeral will be held Monday afternoon, leaving the late home, 1111 Virginia Avenue, at 2 o'clock, services in the Lutheran church at Sharpsburg at 2:30 o'clock by Rev. Mr. Chapman. Internment in Mountain View Cemetery." ⁹⁹

In January 1936, Benjamin Swain was confined to his home with a severe attack of Grippe. 100

On May 8, 1939 Jessie A. Swain of Potomac, MD [Lock 21] died;¹⁰¹ he was a brother to Charles Henry Swain, see above obituary. Jessie's son, Robert Lee and Virginia Mae Swain (married in 1930) continued to live in the lockhouse, paying \$5 per month rent. They started a family.

Clifford C. Swain was an independent grocer as recorded in the city directory for 1937-38, ¹⁰² 1940-41, ¹⁰³ 1942-43 ¹⁰⁴ and 1945-46. ¹⁰⁵ In each reference the retail grocery and the residence had the same address, 112 S. Cannon Ave., which would suggest the Swain family lived above or behind their grocery store, it being one structure. He had probably left the shoe factory job.

Howard Marcellus Swain, son of Howard Milton Swain, grandson of Benjamin Swain, Jr., great-grandson of Benjamin Swain, Sr., and great-grandson of Samuel Johann Boyer, grew up in Sharpsburg, graduated from Boonsboro High School in 1943 and Columbia Business College in

Hagerstown, MD in 1943. Marcellus lived in Washington County, MD all of his life and knew many of the people in this story.

Then World War II came along and men had to register for the draft, including:

Clifford Charles Swain, born June 4, 1890, living at 112 S. Cannon Ave., Hagerstown, Md. and self-employed. ¹⁰⁶ Roy Mowen, 1452 Oak Hill Ave., Hagerstown, Md. would always know his address. He was 51 years old, height 5'-5", weight 160, blue eyes, brown hair, with light complexion. ¹⁰⁷

Clyde Elias Grove, born May 20, 1879, living in Sharpsburg, Md. and not employed. Allen Grove, Sharpsburg, Md. would always know his address. He was 62 years old, height 5'-5", weight 150, gray eyes, black hair, with light brown complexion. He had a scar on his right fore-finger. 108

Oliver Murphy Grove, born Apr. 20, 1881, living in Sharpsburg, Md. and not employed. Argyl Grove, Sharpsburg, Md. would always know his address. He was 61 years old, height 5'-4", weight 150, blue eyes, black hair, with a light complexion. He had a broken left wrist. 109

John Thomas Murphy, born June 3, 1888, living at 5127 7th street, NW, Washington, D.C. and working for H. Abramson, 7th and L street, NW, Washington, D.C. Anna Murphy, 5702 Wyngate Drive, Bethesda, Md. would always know his address. He was 53 years old, height5'-7½", weight 147, gray eyes, cray hair, with a light complexion. 110

Bertram Earl Swain, born May 17, 1892, living in Keedysville, Md. and worked at Federal Security Agency, St. Elizabeth's Hospital, Anacostia, D.C. Thomas Muck, Glen Echo, Md. would always know his address. He was 49 years old, height 5'-4", weight 168, blue eyes, brown hair, with a ruddy complexion. He had a mole on his left hand.¹¹¹

John David Bell, born Apr. 29, 1885, living at 3743 W street, NW, Washington, D.C. and working for the District Water Department, District Building, Washington, D.C. Mrs. John D. Bell, of the home address, would always know his address. He was 56 years old, height 5'-6½", weight 198, blue eyes, brown hair, with a ruddy complexion. He had a scar across the bridge of his nose. 112

Howard Milton Swain, born 11/25/1892, living near Sharpsburg, Md. and working for his father, Benjamin Swain, tenant farmer, Sharpsburg, Md. Minerva Swain, Sharpsburg, Md. would always know his address. He was 49 years old, height 5'-11", weight 155, blue eyes, gray hair, with a ruddy complexion. He was missing a finger off his left hand. ¹¹³ [Correction: Howard owned his own farm, was not a tenant farmer. Minerva was his adult daughter. He wasn't missing a finger, but a fingertip on the 4th digit of his left hand. Howard requested and was granted an exemption for H. Marcellus Swain from the draft because he needed his adult son to stay and work the farm, along with his grandfather Ben, Jr's farm as they had no other sons to work the 182 acre Howard Milton Swain farm and the 218 acre Ben Swain, Jr. farm located on Mondell Road, Sharpsburg, MD.]



Frederick Joseph DeLauney, born Nov. 5, 1889, living at 1207 Dale Ave. SE, Roanoke, Va. and working for Norfolk & Western Railway Co., Roanoke, Va. Mrs. Macy May DeLauney, of the home address, would always know his home address. He was 52 years old, height 5'-7½", weight 130, brown eyes, cray hair, with a light complexion. The big toe on his right foot was crooked. 115

Elbert Crockett DeLauney, born Aug. 3, 1896, living at 217 Berkley Ave., Va. Heights, Roanoke, Va. working in the General Office, Norfolk & Western Railway Co., Roanoke, Va. Mrs. Anna G. DeLauney, of the home address, would always know his address. He was 45 years old, height 5'-4", weight 140, blue eyes, black hair, with a light complexion. 116



He was 18 years old, height 5'-7", weight 130, blue eyes, blonde hair, with a light complexion. He did serve in WW II and Korea.

On July 27, 1941, Robert D. Swain died; his obituary read: "Robert Swain died at his home, 33 Conococheague street, Williamsport, at 4 o'clock Sunday morning after a short illness of kidney trouble, aged 61 years.

"He was the son of the late Henry and Annie Swain of Sharpsburg where he was born and raised.

"He is survived by his wife Mary (McKelvey) Swain and children: Robert, of Detroit; Nobel, Martinsburg; Mrs. Pauline Shipley, Williamsport; Mrs. William Byers, Williamsport; Mrs. J. W. Pinkston and Mrs. Charles Pinkston both of Salisbury, N. C.; Misses Genevieve, Juanita and Ruth, all at home; sisters and brothers, Leonard and Clifford Swain, Hagerstown; Mrs. Roy Stubbs, Hagerstown; Mrs. Lila Hebb,

Hagerstown; Mrs. Guy Stockslager, Maugansville; Mrs. Melvin Butts, Hagerstown; Mrs. Reba Crampton, Fairplay; also 12 grandchildren.

"Funeral services on Tuesday afternoon meeting at Leaf funeral home, Williamsport at 1 o'clock where short services will be held at 1:30 with further services at the Lutheran Church, Sharpsburg, at 2 o'clock with Rev. Mr. Chapman officiating; interment in Mt. View cemetery, Sharpsburg. The body may be viewed at the Leaf funeral home from 7 until 10 o'clock this evening."

On March 19, 1942, Maxwell L. Swain, joined the Army. The local newspaper subsequently reported: "Pvt. Maxwell L. Swain, son of Mr. and Mrs. Clifford C. Swain, 112 Cannon avenue, has been promoted to private first class. His address is Co. H, 423 Inf. 106 Div., APO 443, Fort Jackson, S.C." Later that same year the local newspaper reported: "Maxwell L. Swain, son of Mr. and Mrs. Clifford C. Swain, has been assigned to Pennsylvania State College as an air crew trainee under the Army Air Force college training program." 121

From the **Sharpsburg Letter** we read: Mrs. Laura DeLauney visited over the week-end with her daughter, Mrs. Clifford [Mary Savilla DeLauney] Swain, Hagerstown. Mrs. Raymond Swain

had been ill for several weeks. Mrs. Benjamin Swain has been visiting in Hagerstown with Mr. and Mrs. John Swain. Mrs. Howard Swain, who has been ill, is improving slowly. 122

In January of 1944, Benjamin Swain was confined to his home by illness. 123

The War went on; then came the fateful news:

"Mr. and Mrs. Clifford C. Swain, 112 South Cannon avenue, have received a telegram from the War Department stating that their son, Staff Sgt. Maxwell L. Swain, is reported missing in action in Germany since December 21. Sgt. Swain entered the service immediately after graduating from Hagerstown High School in 1942 and has been overseas about six months." ¹²⁴

Early the next year there was a follow-up telegram as reported in the newspaper:

"Parents Notified of Sgt. Swain's Death Local Soldier Dies in Action, War Department Reports

Mr. and Mrs. Clifford C. Swain, 112 South Cannon avenue, have received word from the War Department that their son, Sgt. Maxwell L. Swain, who was reported as missing in action in Germany in December 1944, is now officially listed as dead, as of that date.

Sgt. Swain, who was 20 years old, attended Hagerstown High School and graduated in 1942. He entered the service in March 1942 and after receiving his basic training at Fort Jackson, S.C., he entered Pennsylvania State College for a six month course under the Army Specialized Training Program, and finished his training at Camp Atterbury, Ind.

He went overseas in October 1944, with the 106th 'Golden Lion' Infantry Division, a unit that participated in three major engagements, the Rhineland, Ardennes and Central Germany. Sgt. Swain was entitled to wear the Combat Infantryman's Badge, and European Theater of Operations ribbon with three battle stars.

Besides his parents, he is survived by one sister, Mrs. Charles J. Klahr, Washington, D.C.; brothers, Eugene and Richard, at home, and grandmother, Mrs. Laura B. DeLauney, Sharpsburg." ¹²⁵

S/Sgt. Maxwell L. Swain remained listed as missing in action for some time. His parents maintained a scrap book of newspaper clippings about Washington County war casualties for many of the war months. The State Veterans Commission initiated an effort to permanently list all of Washington County casualties in World War II. Mr. & Mrs. Swain loaned their scrap book to the Commission. At that time there were eight local men still listed as missing. ¹²⁶

Life had to go on and the Sharpsburg correspondent noted the Clifford Swain family visit to Mrs. Laura DeLauney on Sept. 6, 1946. Another newspaper reported: "Elmer Lester Swain, well-known quarry operator and a Republican leader of the Williamsport district, will be named county roads superintendent by the Board of County Commissioners in formal meeting this afternoon. Swain, a brother of John L. Swain, local insurance agent, and son of Benjamin Swain, well-known Sharpsburg farmer, is said to have had little opposition for the appointment." ¹²⁸

The next year the Red Cross and Veterans Commission acknowledged Mrs. Clifford Swain as a Gold Star Mother. 129

In March 1949 we read in **Sharpsburg Letters** we read: Benjamin Swain has returned to his home after treatment at the hospital. His wife has also been a hospital patient. Both are now improving. And Mr. and Mrs. Robert Swain, Hagerstown, Miss Martha Poffenberger, Washington, visited Mr. and Mrs. T. R. Poffenberger on Sunday. 130

1949 was a difficult year for the Clifford Swain family. In May the local newspaper reported:

"Remains Of Four County War Dead Are Coming Home

The remains of four county men are being returned to this country for reburial aboard the Army Transport Haiti Victory. The war dead are being returned from Army graveyards in the European Theatre of Operations. The Army listed the following county men, with their next of kin: . . . S/Sgt. Maxwell L. Swain, Army, Clifford C. Swain, 112 South Cannon avenue, Hagerstown."

Details were unknown until the newspaper reported:

"S-Sgt. Swain To Be Reburied June 15th Local Man Killed in Battle Of The Bulge In 1944

Funeral services for S. Sgt. Maxwell L. Swain, son of Mr. and Mrs. Clifford C. Swain, 112 S. Cannon avenue, who was killed in action overseas, will be held from A. K. Coffman funeral home on Wednesday afternoon at 1:30 o'clock with the Rev. Donald Stonesifer and the Rev. John Aurand officiating. The re-burial will be in Antietam National Cemetery, Sharpsburg.

The local soldier was killed in action during Battle of the Bulge, Dec. 21, 1944. His body was not located until May, 1947, when an elderly German located the graves of five American soldiers in a cemetery at Bleialf, Germany. The local soldier's body was re-buried at a military cemetery in Belgium.

Sergeant Swain was a member of the famous 106 Golden Lion Infantry Division of the 423rd Regiment. He took his training at Fort Jackson, S.C. and Camp Atterbury, Ind. He went overseas in October, 1944.

He was a graduate of the local high school class of 1942. He was 20 at the time of his death. He was awarded the combat infantry badge E.T.O. ribbon with three stars and Purple Heart, all posthumously.

Besides his parents he is survived by a sister, Mrs. Charles J. Klahr, Washington, D.C.; brothers Pfc. Alfred Eugene, with Army Air Forces, Scott Field, Ill.; Richard Lee, at home; grandmother, Mrs. Laura B. DeLauney, Sharpsburg; one niece and a nephew." ¹³²

A few days later the family printed a "Card of Thanks" to their many friends and neighbors for their kindness and sympathy. 133

They got through the summer and returned to Sharpsburg to visit her mother in the fall. 134

"She will be at her home 5 p.m. Monday and at the Lutheran Church, Sharpsburg from 10 a.m. Tuesday until 2 p.m. Funeral service will be held Tuesday afternoon at 2 p.m. at the Lutheran Church, Sharpsburg by the Rev. Dr. William A. Wade. Interment in cemetery adjoining." ¹³⁵

Summer of 1950 saw, Alfred Eugene Swain, who had already enlisted in the Air Force receive a promotion as reported in the newspaper:

"Alfred E. Swain, of Hagerstown, has been promoted to corporal, effective March 15, it was announced at Brooks Air Force Base, San Antonio, Texas, where he is now stationed. He attended radio mechanics school at Scott Field, Illinois. His parents reside at 112 South Cannon Avenue." 136

Several of the Swain family resided in or near Hagerstown: A. Eugene, USAF, residence 112 S. Cannon, Ave.; Clifford C. (Mary S.) grocery 112 S. Cannon Ave., residence ditto; Elmer L. road engineer for Washington County Roads Dept., residence in Williamsport; Elwood E. L. (Betty J.), welder Victor Products Corp., residence 941 Maryland Ave.; H. Marcellus, junior accountant Robert C. Triesler, residence in Boonsboro; and Robert (Betty) air conditioner installer, residence 113 Belview Ave.¹³⁷

In the **Sharpsburg Letter** the correspondent reported: Benjamin Swain, who has been a patient at the county hospital, is now a patient at the convalescent home in Williamsport. And Mr. and Mrs. Robert Swain, Hagerstown; Miss. Martha Poffenberger, Washington, were Sunday guests of Mr. and Mrs. T. R. Poffenberger. ¹³⁸

The years passed, presumably with continued visits and the children growing up. In early 1951 Mrs. Laura DeLauney observed her 83rd birthday and many of the family came to help her celebrate. By 1951, Alfred Eugene Swain, had gotten married while still in the Air Force. The Sharpsburg correspondent reported: "Sergeant Swain here. S/Sgt. and Mrs. Eugene Swain returned to San Antonio, Texas, after a furlough in their respective homes in Hagerstown. Sergeant Swain is on duty at Brooks Air Force Base. The couple have an apartment at 306 Berkshire Road, San Antonio, Texas. Mrs. Swain is the former Miss Margaret Jane Baker, daughter of Mr. and Mrs. Jesse Baker, Hagerstown. Swain is the son of Mr. and Mrs. Clifford Swain, South Cannon Avenue, Hagerstown. While on furlough they visited Sergeant Swain's grandmother here, Mrs. Laura DeLauney."

The DeLauney and Swain families got together, to celebrate Mrs. Delauney's 85th birthday. ¹⁴¹ Mysteriously, the families celebrated her 85th birthday, again, one year later. ¹⁴² The Sharpsburg correspondent continued to report

the Clifford Swain family visits to Mrs. DeLauney on April 12, 1955¹⁴³ and on April 10, 1958. 144

On Aug. 9, 1955, Benjamin Swain died, his obituary read: "Benjamin Swain, well-known farmer of the Sharpsburg district, died at Williamsport Sanitorium Monday following an illness of five and one-half years. He was 89 years of age.

"The son of the late Benjamin and Elizabeth (Boyer) Swain of Sharpsburg, he was the last surviving member of his immediate family, and was a member of Trinity Lutheran Church, Sharpsburg.

"Surviving are: sons, E. Lester Swain, Williamsport; Howard M. Swain, Sharpsburg; John L. Swain, Halfway; Raymond E. Swain, Sharpsburg; cis grandchildren and four great grandchildren.

"Funeral services will be held at 2 p.m. Wednesday at the Leaf Funeral Home, Sharpsburg, with the Rev. Dr. William Wade officiating. Interment will be in Mountain View Cemetery, Sharpsburg. The body may be viewed at the funeral home Tuesday evening from 7 to 10, and on Wednesday until the time of the service." ¹⁴⁵

Shipley & Co. and Secretary Saunders Home Improvement Co. Inc., residence Boonsboro. 146

Then came the wedding as reported in the Hagerstown newspaper:

"Miss Patricia Taylor and Mr. Richard Swain Marry

A pretty summer wedding on Sunday, the tenth of August, united in marriage Miss Patricia Ann Taylor, daughter of Mr. and Mrs. Vernon W. Taylor, Highfield, and Mr. Richard Lee Swain, son of Mr. and Mrs. Clifford Swain, Hagerstown.

The young couple were married before an alter embankment of white gladioli and pom poms intermingled with glowing tapers in cathedral candelabra in St. Stephen's Reformed Church, Highfield. The Reverend Claude Corl officiated at the double ring service at seven o'clock in the evening in the presence of a large assemblage of relatives and friends.

Given in marriage by her father, the bride wore a charming waltz-length gown of French Schiffli embroidery over gleaming bridal satin. The Basque bodice, designed with a portrait neckline and off the shoulder sleeves, was complemented by a bouffant skirt of Schiffli embroidery over tiers of nylon tulle. She wore satin elbow mitts and a pure silk illusion veil attached to an Aleneon lace shell trimmed with satin and seed pearls. She carried a white prayer book topped with a white orchid nestled in a shower of satin ribbons.

The bride chose her sister, Miss Donna Dell Taylor, as maid of honor. She was attired in a gown of Dior blue with all-over white embroidery and a matching blue silk braid bandeau with a tiny nose veil. A corsage of pink and white carnations complemented her ensemble.

Miss Bonnie Taylor, sister of the bride, was the bridesmaid, wearing a pink gown like that of the maid of honor and a matching pink Bandeau adorned with white flowers. She also added a corsage of pink and white carnations.

Mr. John P. Randolph, Emmitsburg, served as best man for Mr. Swain.

For her daughter's wedding, Mrs. Taylor chose a frock of pale blue linen, adding white accessories and a corsage of white carnations. Mrs. Swain, mother of the bridegroom, attended in a royal blue and white print dress, which she also accented with white accessories and a corsage of white carnations.

Reception Given

A reception was given immediately following the ceremony in the church reception room.

The bridal table, laid with a lace cloth, was centered with a four-tiered wedding cake in a circle of ivy and lighted candles. Mrs. Gene Swain, sister-in-law of the bridegroom, served the cake, and Mrs. Henry Gilland, cousin of the bride, presided at the punch bowl, which was placed on a table appointed with ivy and lighted tapers around a centerpiece of white carnations and asters.

The couple planned a wedding trip to an unannounced destination. For traveling, Mrs. Swain changed into an aqua and white dress, with matching accessories and the orchid lifted from her prayer book. On their return, they will reside in their newly-furnished apartment at 16 West Wilson Boulevard, this city.

Mrs. Swain is a graduate of Smithsburg High School, class of 1956, and Waynesboro Business College, class of 1957. Prior to her marriage, she was employed at Frick Company in Waynesboro.

Mr. Swain graduated from Hagerstown High School in the class of 1954, and served four years with the United States Air Force, completing a tour of duty in Labrador. He is employed as an electrician with Miller-Liskey Electric Company, Inc., in this city.

The bridegroom's parents were hosts to members of the wedding party at their home following the rehearsal on Saturday evening." ¹⁴⁷

Mrs. Reba Elizabeth Crampton died yesterday at 5:30 a.m. at her home, Fairplay, Route One, after a short illness, aged 70 years.

Born and reared at Sharpsburg, she was the daughter of the late Henry and Annie (Wilson) Swain, Sharpsburg.

Surviving are her husband, Oliver; daughters, Mrs. Martha Henson, Hagerstown; Mrs. Mary Ruth Rager, Hagerstown; Mrs. Virginia Rager, Hagerstown; two sons, William, Hagerstown; Raymond, Fairplay; Chester, at home; sisters, Mrs. Lila Hebb, Hagerstown; Mrs. Grace Butts, Sharpsburg Pike; Mrs. Mamie Stockslager, Hagerstown; brother, Clifford Swain, Leonard Swain, Sharpsburg; and 28 grandchildren.

This was the first mention found of a sister older to Clifford Swain. The obituary also provides the married name of Clifford's other sisters, although the spelling of names remains to be verified.

In the fall of 1959 the National Park Service tried to raise the rent [at Lock 21] from \$5 per month to \$21 per month. Robert Swain complained to Justice William O. Douglas, who intervened with Director Wirth, and the rent was adjusted to \$10 per month. 152

In the fall of 1960 the death of Mrs. DeLauney was reported:

"Mrs. Laura Belle Delaunev

Mrs. Laura Belle Delauney of Sharpsburg died at her home yesterday evening after a long illness, aged 92.

Born and raised in Sharpsburg, she was the daughter of the late John W. and Helen (Hines) Fisher, and was a member of the Sharpsburg Trinity Lutheran Church and the Order of the Eastern Star, Areme Chapter.

Surviving are the following: sons, Mervin and Lloyd, Sharpsburg, and Fred, Roanoke, Va.; a daughter, Mrs. Clifford Swain, Hagerstown; sisters, Mrs. J. D. Kemp, Tilghmanton; Mrs. Helen James, Hyattsville, and Mrs. W. E. Allison, Roanoke; a brother, Lloyd Fisher, Roanoke; 11 grandchildren, 12 great grandchildren and three great-grandchildren.

Services will be held Friday at 2 p.m. from the Leaf Funeral Home at Sharpsburg, the Rev. Charles Birx officiating. Burial will be in Mountain View Cemetery, Sharpsburg.

From this obituary, we obtain the date Mrs. DeLauney died and confirm her birth year, 1868, despite reports of the family celebrating her 85th birthday twice. Marcellus Swain relates that he used to pick up Clifford Swain, Jr., from Prince George's Co. when he was working at the Rosecroft Race Track in the 1960's and take him to and from Sharpsburg to visit the DeLauneys. He said Clifford, Jr., had a restaurant and pizza place.

On Sunday, July 16, 1961, the 9th reunion of the Poffenberger Clan was held at Taylor Memorial Park, Keedysville. 112 relatives and friends gathered in the pavilion for a picnic lunch and program. President Marcellus Swain welcomed the group. Benjamin Swain had the largest family in attendance.¹⁵⁴

Except for a 1964 story about Mrs. Clifford Swain's foot surgery, ¹⁵⁵ the family stayed out of the news for the next several years, until interest in the C & O Canal revived in the latter half of the decade as reported:

"Area Men To Be In C&O Canal Movie

"Two area men, former workers on the Chesapeake and Ohio Canal, will be featured in 'The Magnificent Ditch,' a television documentary on the history of the canal next Wednesday at 7:30 p.m.

"Ralph [sic. Raleigh] S. Bender, 73, of Sharpsburg, a former C&O boat captain and Clifford C. Swain, 75, of Hagerstown, will appear on the special of the 185-mile waterway on WMAL-TV, channel 7.

"Swain, who lived and worked on the canal for the first 20 years of his life, will take viewers on a hike along the towpath from Cumberland to Georgetown. The show will be telecast in color." ¹⁵⁶

A similar story appeared early the next year:

"A Lingering Look At the Old C and O

One of Washington's most picturesque natural landmarks, the historic Chesapeake and Ohio Canal, is the subject of WMAL_7's first color documentary this Wednesday (7:30 p.m.).

Swain takes viewers on a nostalgic trip along the Chesapeake and Ohio Canal Wednesday on WMAL-7.

THROUGH HIS EYES - Clifford

John Batchelder will narrate the half-hour film, which includes a history of the 185-year-old waterway and report on its current status as a national monument.

His special guest will be one Clifford C. Swain, 75, who lived and worked on the canal as a youth and will conduct viewers on a towpath tour from Cumberland to Georgetown.

Also featured on the program will be two former lock-keepers of the canal, 94-year-old Dennis Crabtree of Oldtown, Md., and 67-year old Robert D. Swain (Clifford's nephew) of Swain's Lock near Great Falls, Md."¹⁵⁷

Marcellus and Marcia Swain viewed the television documentaries about the Swains and the canal at that time.

And two days later in the regular newspaper we read:

"Old Canal Days Recalled

Washington County men who used to work on the C & O Canal will participate in a televised documentary on the famous waterway Wednesday.

'The Magnificent Ditch' is the title of the telecast at 7:30 p.m. on Channel 7.

The program on the history of the canal and its present status as a park will feature 75-year old Clifford C. Swain, Hagerstown. He lived and worked on the canal for the first 20 years of his life. Swain will take viewers on a hike along the towpath from Cumberland to Georgetown.

A former C & O Canal boat captain, 73-year old Raleigh S. Bender, Sharpsburg, will also be featured.

Two former lockkeepers will be participants. They are Dennis Crabtree, 94, Oldtown, and Robert Swain, 67, Great Falls.

Ross Holland, historian for the C & O Canal National Monument, served as historical advisor.

The Williamsport C & O Canal Club called the attention of the public to the telecast of local interest. The club was organized a decade ago to assist with development of the canal into a national park, and has a large membership throughout the East.

John Batchelder of WMAL-TV will narrate the program." 158

The astute reader will notice that Clifford Swain never tended a lock on the C & O Canal. He worked on the canal for many years and would have locked through Swain's Lock [Lock 21] in Montgomery County, MD many times. A Swain family history of the lockkeepers at Lock 21 remains to be compiled.

In January 1967, it was reported that Clifford Swain was a surgical patient at the Washington County Hospital, Hagerstown, MD. 159 He recovered and the photograph to the right of Clifford and Mary Swain was taken at their home in Hagerstown, MD, 1970.

After Robert D. Swain, Jr. died on June 3, 1967¹⁶⁰, the Park Service negotiated a



higher but still modest annual fee reflecting their occupancy and income from canoe and boat

rentals and refreshment sales. The Swains installed utilities and modernized the interior of the lockhouse themselves. ¹⁶¹ During flooding of the Potomac River and the Canal, the first floor of the lockhouse flooded. The house had markings on the outside showing how the high the water level was and the year.

Marcia Swain visited the lockhouse about 1986 when she was living in Montgomery County, MD. Robert D. Swain, Jr., had died in 1981. His widow was still living in the lockhouse. Marcia spoke with Mrs. Robert D. Swain, Jr., for some time and met their son, who was running a canoe rental business at the lock.

Several years passed and in 1971, a sister to Clifford C. Swain died as reported:

"Mrs. Grace M. Butts

Mrs. Grace M. Butts, 73, Hagerstown, Rt. 3, died at the Washington County Hospital Sunday evening.

She was born in Sharpsburg, daughter of Henry and Anna Wilson Swain.

She is survived by husband, J. Melvin Butts; son, Melvin A. Butts, Hagerstown; brother, Clifford Swain, Hagerstown; sisters, Mrs. Lelia Hebb, Mrs. Mamie Stockslager, both of Hagerstown; two grandchildren.

Funeral services will be held at the Minnich Funeral Home, Wednesday at 10:30 a.m., the Rev. John Lebo officiating; burial in Mountain View Cemetery, Sharpsburg. The family will receive friends at the funeral home this evening from 7 to 9."¹⁶²

Later that fall, 15 C & O Canal workers held their first reunion at Barron's Museum and General Store in Snyder's Landing, near Sharpsburg, MD. The attendees included: Levi and Nora Bender, Hagerstown; William O. and Mary Lee DeLauney, Sharpsburg; Nellie and William Saylor, Martinsburg, W. Va.; Clifford C. Swain, Hagerstown; Martin Stevens, Shepherdstown; Lester Ronald and Mary Schroeder, Rockville; Lester and Mary Mose, Sharpsburg; Hazel Colbert, Hagerstown; Nellie P. Weller, Cumberland; and Geneva Poffenberger, Sharpsburg. 163

In February 1972, the Washington County Museum had an exhibit of the C & O Canal artifacts and paintings. Sunday afternoon shows were presided over by Hooper Wolfe and Clifford Swain, the featured personality

in the C&O Canal film, "The Magnificent Ditch." ¹⁶⁴ Mr. Barron wrote the article and probably loaned several artifacts.

In May 1972, it was reported that Clifford C. Swain was a patient at Washington County Hospital. He did recuperate and on July 4, 1973 gave Woody Wineholt Park Ranger on the C & O Canal the first of what turned out to be five oral histories. In the previous photograph, Clifford C. Swain is standing beside one of his artifact display cases, in the basement of his home. Note the photograph on the wall just above Clifford's head is the one of his father, taken in 1925 and included earlier.



About that same time, 1970 – 72, Clifford C. Swain revisited Snyder's Landing as shown in the adjacent photograph. Note that with the canal no longer being in operation the Park Service had replaced the suspension bridge with a conventional bridge using the historical foundations. Look closely to see the graffiti "H. Swain" written on the concrete foundation.

Here Clifford was kneeling beside the concrete foundation to inspect his father's handiwork.

On Saturday, September 15, 1973, Barron's C & O Canal Museum and General Store organized the 3rd Annual Canal Worker Reunion at their place. Boat captains expected included: Orville Delauney, Ronald Schroeder, Lester Mose and Will Saylor. Boat crew members expected included Clifford Swain of Hagerstown, the most senior in his mid-eighties. ¹⁶⁷ A week later, two newspapers reported on the event (identical articles under Harold Muddiman's name), without mentioning Clifford Swain's name. Jacob Myers of Hancock was reported as the oldest man at Saturday's reunion; it seems reasonable that Clifford Swain did not attend. ¹⁶⁸ Later that same year, Frank Zimmerman, a former boatman recalled his days on the canal and the sound of mule bells. ¹⁶⁹ Again, no mention of Clifford Swain was found.

Apparently, Clifford Swain's health was deteriorating because the next entry was his obituary: "Clifford C. Swain

Clifford C. Swain, 84, of 112 South Cannon Ave., died on Sunday at the Washington County Hospital.

Born in Sharpsburg, he was a son of Henry and Anna Wilson Swain. He was a member of Holy Trinity Lutheran Church of Sharpsburg. He was a retired independent grocer and had boated on the C&O Canal.

He is survived by his wife, Mrs. Mary DeLauney Swain; a daughter, Mrs. Marjorie C. Klahr of Clinton; sons Alfred E. Swain of Maugansville, Richard L. Swain of Hagerstown; sisters Mrs. Lila O. Hebb of Hagerstown, and Mrs. Mamie F. Stockslager of Hagerstown, and 11 grandchildren, and five great-grandchildren.

Services will be held at the Minnich Funeral Home, 415 East Wilson Blvd., at 10 a.m. on Wednesday. The Rev. G. Edward Whetstone and the Rev. John B. Mills will officiate; burial will be in Mt. View Cemetery in Sharpsburg.

The family will receive friends at the funeral home on Tuesday evening from 7 to 9." 170

Marcia Swain relates that there are many descendants of the Sharpsburg, Md. C. & O. Canal families who have held a family reunion every year for the past 65 years. The Otho J. Poffenberger Family Reunion is held each year in July in the Taylor Park, Keedysville, Md. There are descendants from the following canal families: Poffenberger, Swain, Boyer, Mose, Renner and Bender. These families have intermarried for several generations and many still live along the canal.

These canal families are mainly buried in two Washington County, Md. cemeteries: Salem Evangelical Lutheran Church, Bakersville, Md. (founded about 1820) and the Mt. View Cemetery, Sharpsburg, Md. (founded after the Civil War, about 1880).

From a local newspaper the following obituary: "John L. Swain, real estate firm owner dies at 80. – John L. Swain, 80, of 1917 Virginia Ave. [Hagerstown, Md.], died at the Washington County Hospital on Tuesday morning.

"He was born in Washington County, the son of the late Benjamin and Margaret (Poffenberger) Swain. He was a member of the Church of the Brethren.

"He owned and operated the John L. Swain Real Estate Business for 50 years, and was a member of the real estate board.

"He was an appraiser for Governmental properties, Banks, and the Maryland State Roads Commission for many years.

"He was a member of the Washington County Historical Society, the Hagerstown Fair Board, and the Halfway Fire Company.

"He is survived by his wife, Oma L. Carter Swain, of Hagerstown, one brother, Raymond Swain, of Hagerstown, and a number of nieces and nephews.

"Services will be held at the Coffman Funeral Home on Thursday at 2 p.m. The Rev. Dean M. Miller and the Rev. Rowland Reichard will officiate. Burial will be in Rest Haven Cemetery.

"The family will receive friends at the funeral home tonight from 7 to 9."¹⁷¹

Lastly, we found the following obituary: "Elwood Luther Eugene 'Bert' Swain, 82, of Ravenwood Lutheran Village, Hagerstown, and formerly of Keedysville, died Thursday, Nov. 9, 2006, at Washington County Hospital. Born Oct. 2. 1924, in Williamsport, he was the son of the late Bertram Earl and Margaret May Cornwell Swain. He was employed by Fairchild Aircraft for 38 years, as a stationary engineer. He was a veteran of World War II, serving in the army. He was a member of Grace Brethren Church in Hagerstown. He was a member of Morris Frock American Legion Post 42. He is survived by his wife, Betty Jane Smith Swain, whom he married Nov. 21, 1942; two daughters, Eugenia L. Vincent of Hagerstown and Elizabeth A. Moore of Martinsburg, W. Va.; one sister Evelyn Hudson of Washington, D.C.; two grandchildren; and three great-grandchildren. He was preceded in death by four sisters, Mary Snyder, Birdie Rubright, Lottie Eckstine and Bessie Custer; and one brother, John Swain. Services will be Monday at 11 a.m., at Bast Funeral Home in Boonsboro. The Rev. Dean P. Pryor will officiate. Burial will be in Boonsboro Cemetery. The family will receive friends Sunday from 3 to 5 p.m. at the funeral home." 172

Frisby Tired of Life.

Frisby T. Staubs, of Sharpsburg, attempted suicide Monday about half-past one o'clock by hanging himself in his stable. Fortunately, he was discovered in time and cut down before life was extinct. He placed a long bench on end and leaned it against a rafter. To the upper end of the bench he attached a rope and standing on a box he tied the other end around his neck. When ready he kicked the box away and dangled in space. While so hanging, slowly strangling to death, Mrs. Charles Swain, a neighbor, burst into the stable and found him. She called for help and John Early, who was working in a garden, hastened to the stable and cut Staubs down. He was unconscious when taken down but soon revived, as he was rescued from his dangerous position before he had been hanging more than a moment or two. Staubs is a cripple and earns a livelihood by hauling goods. On Friday he hauled a load of ice from Hagerstown. During the evening someone stole \$18 from him, and this loss, combined with other things, had a very depressing effect on him. He said that unless he found the money by Saturday evening he would put himself out of the way. Monday morning he went down to the hotel and to the crowd standing about said that he had not found his money and wanted them to see that he got a decent burial. While not attributing much importance to his remarks, neighbors watched him more or less, and When Mrs. Swain saw him go into the stable she became suspicious and followed him with the result as told above.

When he revived sufficiently to speak after being cut down, Staubs asked why he had not been left alone, as he wanted to die and would kill himself. A close watch is being kept on him to see that he does not attempt to take his life again. Staubs is about forty-six years old and resides on Antietam street in Sharpsburg with his wife and four children. His crippled condition is a great drawback to him, as it curtails the ways in which he can gain a living, and all who know him are sorry that he was driven to attempt so rash an act.

Staubs was in Hagerstown Tuesday, and to a reporter there he expressed regret that he had tried to kill himself, and said he would do so no more. His eighteen dollars was found under a log where he had placed it for safe keeping while he was indulging in a spree.

This Indenture, Made this 12th day of August eighteen hundred and seventy between John T. Swain of Washington County, State of Maryland, of the first part, and Henry Thomas Weld of Allegany County, State of Maryland, of the second part. Whereas the said Henry Thomas Weld has this day sold to the said John Swain the Canal Boat called "William M. Hill" at and for the sum of Two thousand dollars, which the Swain is to pay unto the said Weld and his assigns in installments of Forty dollars each for the first twenty trips and thirty five dollars for each subsequent trip made by said boat from Cumberland to Georgetown, Alexandria, or Washington City or other intermediate points, until the entire purchase money is paid with interest thereon from this date crediting the respective payments thereon, as of the time when such payments shall be made. And Whereas, it was a part of said contract of purchase and sale between the said Swain and the said Weld, that the said Swain shall use the said boat in freighting coal from Cumberland to the points aforesaid, in regular trips with as much expedition and regularity as can be reasonably done with night and day stock and to give a preference in freighting to the coal of such company or persons as said Weld may from time to time direct; provided such person or persons are ready to load him at the current rates of freight payable by the large companies for a like service, within a period of twenty four hours exclusive of Sundays after his reporting for loading, and keep said boat in proper repair; and that the said party of the first part shall not sell, or dispose of, or lease, or mortgage said boat without the written consent of the agent of said Weld, endorsed on this instrument, before the said boat shall have been entirely paid for; all of which said stipulations the said Swain hereby covenants and agrees with the said Weld and his assigns to fulfill and perform.

Provided Always, that if, from any cause whatsoever, said Weld shall not be prepared with coal within twenty four hours of the boat being reported by the captain as ready to receive her load, then all claims of said Weld to the services of the boat for that trip is cancelled, except so far as his right to claim the trip money is concerned. And whereas the said Swain is anxious to secure unto the said Weld and his assigns the regular and due payment of each and every said installment of said purchase money, and also to secure the said Weld and his assigns the regular, prompt and due performance of the covenants aforesaid and the said [Swain] is willing to execute these presents.

Now this indenture Witnesseth, that the said Swain for and in consideration of the premises, hath granted, bargained and sold and by these presents doth grant, bargain and sell unto the said Henry Thomas Weld, his executors, administrators and assigns, the canal boat called "William M. Hill" to have and to hold the same unto the said Henry Thomas Weld, his executors, administrators and assigns forever.

Provided Nevertheless, and it is hereby declared to be the true intent and meaning of these presents that if the said Swain shall well and truly pay unto said Weld, his executors, administrators or assigns, the aforesaid installments of purchase money upon each and every trip as aforesaid, until the whole purchase money with interest as aforesaid shall be fully paid; and if the said Swain shall well and truly do and perform all the covenants on his part to be done and performed as set forth in this mortgage, then this instrument of writing and every matter and thing herein contained, shall cease and be utterly null and void; otherwise to remain in full force and virtue in law. And this instrument further Witnesseth that it is mutually agreed between the parties aforesaid, that in case of any default upon the part of the said Swain to make regular

payments on account of said purchase money as herein provided, or in case of a failure to make regular trips as aforesaid with said boat, or in case of a refusal or neglect upon the part of said Swain to freight for the company or person designated by said Weld, or in case of a failure or neglect to use all diligence, care and skill in making such trips with said boat, as before mentioned, or in case said boat is not kept in proper repair, or in case of a failure to perform any of the stipulations or recitals in this mortgage named, to be done and performed on the part of the said Swain then, and in either event the said Henry Thomas Weld or his assigns are hereby authorized to take immediate possession of said boat, and after ten days public notice thereof in a newspaper printed in the City of Cumberland, to sell said canal boat at public sale, as mortgagee, to the highest bidder for cash or on credit; and out of the proceeds of such sale pay first the expenses of such sale and advertisement, and then the balance due to said Weld, or his assigns, of said purchase money and interest. In Witness Whereof the said Swain hath hereunto subscribed his name and affixed his seal on the day and year first above written, Test.

Whereas the said Henry Thomas Weld has this day sold to the said Swain the Canal Boat called "Samuel Boyer" at and for the sum of Twenty one Hundred Dollars, which the said Swain is to pay unto the said Weld and his assigns in installments of Fifty dollars each for the first twenty trips and thirty five dollars each for subsequent trip made by said boat from Cumberland to Georgetown, Alexandria, or Washington City or other intermediate points, until the entire purchase money is paid with interest thereon from this date, crediting the respective payments thereon, as of the time when such payments shall be made. And Whereas, it was a part of said contract of purchase and sale between the said Swain and the said Weld, that the said Swain shall use the said boat in freighting coal from Cumberland to the points aforesaid, in regular trips with as much expedition and regularity as can be reasonably done with night and day stock and to give a preference in freighting to the coal of such company or persons as said Weld may from time to time direct; provided such person or persons are ready to load him at the current rates of freight payable by the large companies for a like service, within a period of twenty four hours, exclusive of Sundays, after his reporting for loading, and keep said boat in proper repairs; and that the said party of the first part shall not sell, or dispose of, or lease, or mortgage said boat without the written consent of the Agent of said Weld, endorsed on this instrument, before the said boat shall have been entirely paid for, all of which said stipulations the said Swain hereby covenants and agrees with the said Weld and his assigns to fulfill and perform.

Provided Always that if, from any cause whatsoever, said Weld shall not be prepared with coal within twenty four hours of the boat being reported by the captain as ready to receive her load, then all claims of said Weld to the services of the boat for that trip is cancelled, except so far as his right to claim the trip money is concerned. And whereas the said Swain is anxious to secure unto the said Weld and his assigns the regular and due payment of each and every said installment of said purchase money, and also to secure the said Weld and his assigns the regular, prompt and due performance of the covenants aforesaid and the said Swain is willing to execute these presents.

Now this indenture Witnesseth, that the said Swain for and in consideration of the premises, hath granted, bargained and sold and by these presents doth grant, bargain and sell unto the said Henry Thomas Weld, his executors, administrators and assigns, the canal boat called "Samuel Boyer" to have and to hold the same unto the said Henry Thomas Weld, his executors, administrators and assigns forever.

Provided Nevertheless, and it is hereby declared to be the true intent and meaning of these presents that if the said Swain shall well and truly pay unto said Weld, his executors, administrators and assigns, the aforesaid installments of purchase money upon each and every trip as aforesaid, until the whole purchase money with interest as aforesaid shall be fully paid; and if the said Swain shall well and truly do and perform all the covenants on his part to be done and performed as set forth in this mortgage, then this instrument of writing and every matter and thing herein contained, shall cease and be utterly null and void; otherwise to remain in full force and virtue in law. And this Instrument further Witnesseth that it is mutually agreed between the

parties aforesaid, that in case of any default upon the part of the said Swain to make regular payments on account of said purchase money as herein provided, or in case of a failure to make regular trips as aforesaid with said boat, or in case of a refusal or neglect upon the part of said Swain to freight for the company or person designated by said Weld, or in case of a failure or neglect to use all diligence, care and skill in making such trips with said boat, as before mentioned, or in case said boat is not kept in proper repair or in case of a failure to perform any of the stipulations or recitals in this mortgage named, to be done and performed on the part of the said Swain then, and in either event the said Henry Thomas Weld or his assigns are hereby authorized to take immediate possession of said boat, and after ten days public notice thereof in a newspaper printed in the City of Cumberland, to sell said canal boat at public sale, as mortgagee, to the highest bidder for cash or on credit; and out of the proceeds of such sale pay first the expenses of such sale and advertisement, and then the balance due to said Weld, or his assigns, of said purchase money and interest.
